Board of Selectmen's Meeting,
June 17, 1986

Present: Chrmn. Andrew Woodsome, Jr., Robert Fay, Dennis Abbott, Jean Chick.

So. Maine Finishing: On June 16th. the main building of the Plant burned. DEP was called in. Chrmn. Woodsome reported that he had visited the site this evening before coming to this meeting and that the final step of pumping out the cyanide tanks were being taken care of by Mark StGermaine. The tanks of dipping water was also being pumped out and taken from the site.

LAC: Chrmn. Woodsome said that he had received a call from Roy Snow the President of LAC pertaining to the back unpaid dues of the lots at Lake Arrowhead that the Town plans to place up for Auction in August. Snow said that he did not get to see the letter before it was answered and that he would like a meeting with the Board of Selectmen this weekend to discuss the matter.

Motor Oil: Chrmn. Woodsome said that he had be asked by George Cossar of Roberts Ridge Rd. , if the Town planned to supply the Townspeople with a place to dump the motor oil from vehicles. The Board will discuss this further at a later date.

Computer Selection Comm: Members David Buck, Dianne Holden and Jean Chick met with the Board to discuss the selection of a computer system for the Town as they were charged to do through the Annual Town Meeting in March, members not present were Margaret Beavis, James Carll and Don Turner, Jr.. Selectman Abbott asked if the Committee had plans to go out for quotes, Mr. Buck said that it would be a waste of time as the Committee had talked with serval others that had and that it seemed to come right down to two Companies The Computer Center and Northern Data. The Board agreed that the Town Meeting vote gave the Committee the rights to go forward and make their recommendations to the Board. The Committee will meet once more and will then submit their recommendation to the Board.



Millard Genthner: Mr. Genthner said that he did not come to argue with the Board but would like a yes or no if they intend to enforce the Zoning Ordinance due to the keeping of animals in South Waterboro by Tony Andreottola . Genthner said that his neighbor had panned to attend this meeting but had to be out of town this evening. Selectman Abbott said the Board did intend to enforce the Zoning and that Mr. Andreottola would receive a letter from the Board telling him that the keeping of commercial animals in the Village Zone was prohibited and that if this was not abided by further action would be taken. Mr. Genthner asked that he receive a copy of the letter.

7:30 -PM: Special Town Meeting held in the Town Hall. Followed by the monthly Council Meeting.

Public Auction: Atty. Danylik was called by Jean Chick. Atty. Danylik told Mrs. Chick that the Town could hold two public auctions on Aug. 9th., However he feels that the auctioning off of any lots should not be "red flagged" . It had been the decision to hold two auctions on Aug. 9th. with Map 11 Lots 44 & 44C being auctioned off seperately.

The Board voted to hold just one auction on August 9th. and enclude all the lots. A listing will be readied for publication.
