SELECTMEN'S MEETING MINUTES January 5, 1988

PRESENT: Robert C. Fay, Chairman, Dennis G. Abbott, Andrew C. oodsome, Jr.

DIANNE HOLDEN: Dianne would like to remodel her office to help the bottleneck problem with people coming in and going out of her office. One suggestion was to block off stairwell and put a door to exit in the copy room, or install a door from her office to outside. She also reported that the TAN papers will be ready next Tuesday. The Board voted to have her sent the amount that was voted in at the Special Town meeting for the teachers block grant and to wait on sending the difference. The Board will discuss the sugguestion of a part-time office worker and get back to her.

TIM NELSON: Tim was in to inform the Board of his neighbor that had received wood from the Town. They have moved out and last weekend he saw a truck there picking up the wood. The man told him that he had bought the wood. The Board voted to file this information for a later use.

DOROTHY DUGAS: Mrs. Dugas had permission to build a 25x27 house from Zoning Board of Appeals, but she did not take in consideration of her eaves and she has also added a deck. She lifted her boathouse and had a slab installed and put new cinder blocks and added a new roof that has a pitched roof. She claims she never heard of the eaves being part of her setback and neither did her builder. The Town has given her an easement for her septic system as her lot is undersized. Tim Nelson suggested levying a fine and allow the 3 ft. overhang and the stairs. She would have to upgrade her building application saying that she paid the fine. Board will contact Karen Lovell and ask her for advice. DEP has already been informed on the boathouse and the dirt that had gone into the lake.

RICHMOND STEVENS: The Board informed Mr. Stevens of the upcoming dump hearing. Board had concerns that the dump was closed on Jan. 1 and by 10:00 am on Saturday people were being turned away because it was full. Mr. Stevens informed the Board that he cannot get into Regional Waste after 11:30 am on Saturday. The Town has 3 boxes but will probably have to add one more by spring. The boxes cost \$4700 a piece. The Board feels that they should be able to go to Regional Waste because it is causing a financial burden on Mr. Stevens. Once the incinerator is started Mr. Stevens feels the problem will be solved, as the incinerator will have to burn 24 hours a day. The Town is up to 1900 tons which is a 20% increase. The Board told Mr. Stevens of complaints of Stoney and Mr. Stevens said that he will talk to him and give him a warning. The dump will cost about \$150,000 next year.

GTE BUILDING: The Board will contact Richard Ricker who is in the process of purchasing the GTE building to come in next week at 6:30 pm to talk to the Board. The Board also invited Don Holden, Chairman of the IDC Comm.
