#### NOTES

DEF cannot revoke a permit as long as all requirements are met. Requirements dependent upon type of tanks requested, if an aquifer is involved. Aquifer determined by State maps. It is the choice of the owner to use monitoring wells or double containment.

Prior to 1985 if was not required to register with the State when installing tanks. If old tanks are suspected as still being buried a complaint can be registered, however, you must have some verification.

Mr. Owen has a permit to install two tanks, one to be 8,000 gallons, the second to be 6,000 gallons. They are to be cathodically protected in steel with fiberglass piping. Mr. Owen has chosen to use monitoring wells. The cost is much less using this method than to use double containment. H. A. Mapes is the installer. The location of tanks is on an aquifer and is within 300 ft. of a private water supply.

Mr. Owen meet all requirements of DEP. If he changes anything he would have to reapply.

Over 21,000 gallon capacity total containment is required by the State. A three to five gallon containment is to be installed around fill pipes. Spillage from customers not taken into consideration by DEP.

Board might possibly require Mr. Owen to probe for old tanks. DEP suggested this as a means of determining old tanks existance.

Water table must be 15 ft. for monitoring wells, if not a new system would need to be used.

Things that need to be taken into consideration. Engineered drainage plan for parking lot. Spill containment. Entrances.
