

SELECTMEN'S MEETING MINUTES
April 21, 1992

Regular meeting of the Waterboro Board of Selectmen.

NEW BUSINESS:

REPORT OF STANDING COMMITTEES:

DWAYNE MORIN: Dwayne discussed the following issues and topics with the Board.

Water District Public Hearing are tentatively set for April 30th and May 11th. The Board voted that these dates are okay. Water Task Force meeting to be held on Monday April 27th. to review documents for the hearings.

-Dwayne asked when the Selectmen would like to set the warrant for the June Town Meeting. The Board voted to set the warrant on Tuesday May 5th.

-The Board reviewed Fred Fay's workplan for the ensuing week. The Board approved the workplan. All workplans should be placed into a file with the corresponding timesheets.

-The Parks and Recreation Committee has requested six names of underprivileged children for the Camp Laughing Loon summer camp. The Board voted to have John & Nancy compile a list of names for Parks & Recreation.

-Linda Bergeron has requested to use Friendship Park on Sunday May 3rd to have a picnic for the Tiger Scouts. The Board voted to allow Linda to use Friendship Park.

-At the General Assistant workshop attended by Nancy, she learned that Towns may hold satellite workshops on different GA topics. Nancy would like Waterboro to hold a workshop on Workfare so that neighboring York County Towns can share ideas concerning Workfare programs. The Board voted to have Nancy set up a Workfare Workshop through the GA Officials.

-The Board reviewed the applications received for the Parks & Recreation maintenance and Rte 5 Park Attendant summer positions. Robert Gobeil stated that he would like to hire two maintenance workers and one park attendant and use Chauncey Gerry during the week. The Board mentioned that the idea was to hire two attendants so that Chauncey would not have to work at the beach area. Dwayne asked the Selectmen not to place him on the Application Review Committee because some applicants used his name as a reference. The Board voted to have Nancy represent the Selectmen on the Application Review Committee and that two or three members of Parks & Recreation Comm. also be used on the committee.

Bob Gobeil stated he would choose six applicants for the maintenance positions and four applicants for the Rte 5 Park Attendant position for interviews. The Board voted to have the Committee suggest four persons for the positions so that the Board may confirm their employment.

Dwayne mentioned that Dana Woodsome would like to meet with the Board next Tuesday to review additional costs to have the lights at the Lion's Field installed. Dana has mentioned that the following items will be needed: additional wire, conduits, electrical service, grass seed, fertililzer and lime. Dana will have estimated costs for the next meeting.

The Board reviewed the letter which Steve Levy of Maine Rural Water Assoc. prepared to be sent to the P.U.C. requesting an opinion for the installation of house services in South Waterboro Village. The Board voted to send the letter to the P.U.C. once the letter is placed on Town of Waterboro letterhead.

The Board discussed the request of Mr. Frost for a consent decree on his property located on the Bagley Road. It appears that permits were issued to Mr. Frost with a front year setback of 70 feet when it hould have been 100 feet. This was an oversight by the Code Enforcement Officer. The permits were issued in 1984. The Code Enforcement Officer recommends a Concent Decree with no penalty sum. The Board voted to have the Concent Decree issued for the next meeting so that the Board may sign it.

Dwayne informed the Board that the Crosswalk Ordinance acted upon at last weeks meeting cannot be amedned by the Selectmen because it was enacted at Town Meeting. Amendments must be presented for Town Meeting vote.

The Board voted to place the crosswalk amendment for the intersection of West Road and Rte 202 & 4 and Goodwin Mills Road on the June Town meeting warrant.

Board signed the warrant for payment of bills and payroll.

Board adjourned at this time to the Town Hall to conduct this month's Council Meeting.
