Voted, Passed.

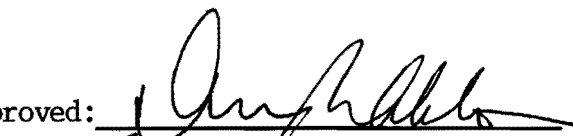
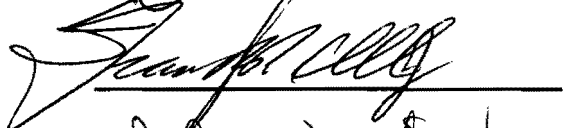
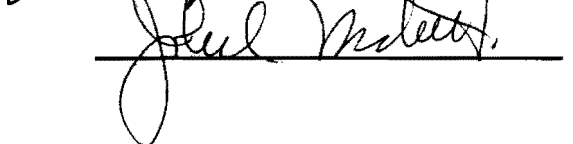
Chm. Abbott made the motion not to hold Council Meeting this month, and the next Council Meeting will be held August 18th. Sel. Monteith seconded,
