Regular meeting of the Waterboro Board of Selectmen.

PRESENT: Chm. Dennis G. Abbott, John C. Monteith and Robert C. Fay.

Also present: Parks & Rec. Chm. Bob Gobeil, Finance Committee member Art Smith.

NEW BUSINESS:

STEVE FOGLIO: Steve was in to discuss the cellular phone. The Board had voted to have the cellular phone removed from Van's truck and installed in Steve's. Steve contacted Star Cellular and the cost to remove from Van's truck to Steve's will be \$75.00. Steve has checked into it, and a new portable will cost \$59.00. Steve would prefer a portable so he can take it in any vehicle that he uses. Star Cellular will broker it out, will not buy back, will just sell it. Used phones go for \$35.-\$50.
