- Motion by Selectman Moore and seconded by Selectman Grover to appoint Jason L'Heureux and Suzanne Cesari as ballot clerks and Bob Gobeil as warden for the November 4<sup>th</sup> election. Vote 5-0-0.
- 5. Motion by Selectman Girard and seconded by Selectman Grover to approve both the Bingo and Game of Chance Sealed Ticket applications. Vote 5-0-0.
- 6. Motion by Selectman Gale and seconded by Selectman Grover and accept and sign the abatements 09-05 through 09-12. Vote 5-0-0.
- 7. Discussed the request from Jane Harriman of Sullies Pub & Grille to change the minutes of the 8/21/07 meeting. Selectman Abbott stated that relative to legal counsels recommendation they can just enter the letter of request into the record as an expression of view. Jane stated that she made her request based on the by-laws. Selectman Abbott noted that they have the flexibility to set aside the by-laws at any point. Selectman Grover stated that he didn't feel at the time that he would do either side justice by voting without more information. Jane stated that she just wants the record to be done correctly.
