# SELECTMEN'S MEETING November 2, 2010

# **APPOINTMENTS**

6:00 – Owens the contract for the work at the Transfer Station. Noted that he did put in a provision that if there is any cost savings, at the discretion of the town, any cost savings due to a lesser amount required for the project of the items specified may be refunded to the contractor at the towns sole discretion. Lucas needs a contract date to execute the bond. Also there is a notice to proceed to be executed once the bond and insurance are in place. Selectman Littlefield questioned if there is anything requiring us to go back out to bid because of the changes and Owens explained that per the bid they have the right to negotiate price.

# SELECTMEN'S REPORT

1. Selectman Littlefield stated that there were an unusually large number of absentee ballots and the girls did an admirable job.

#### **COMMITTEE REPORTS**

Transfer Station Manager – Clint reported on the first quarter and stated that revenue increased \$13,365 and expenses are up 1.5% over last year. Stated that this is the busy time of the year. Recycling July 2009 was 11.53% and July 2010 21.27%. Reported that Household Waste last year was 662 tons and this year 485, they saved \$17,000 on household waste over the same period last year. Reported that he has been taking classes to be recertified to manage the Transfer Station. Also reported that EcoMaine will be returning \$236,000 to towns out of profits which amounts to approximately \$600 per month.

Transfer Station/Recycling Committee – Pat Aurelli reported that she is the new chair of the committee. Reported that they have some good programs which they will continue to work on and will continue to push recycling. Discussed recycling bins and composters.

EcoMaine Rep. – Selectman Woodsome reported that EcoMaine has been negotiating with a couple mining companies to have the ash sifted and will raise about \$280,000 and gain about 6,700 cu. Yds of landfill space.

- 2. Discussed drug free zone signs and Selectman Littlefield noted that this is part of the Park's Ordinance. Motion by Selectman Littlefield and seconded by Selectman Gale for the Town Administrator to move forward with checking on pricing of those so we can comply with the provisions of our own ordinance. Vote 5-0-0.
- 3. Reviewed committee attendance. The two (2) members of concern have only missed one (1) meeting each so the situation has been rectified.
- 4. Motion by Selectman Gale and seconded by Selectman Littlefield to extend the Municipal parking Lot Plowing/sanding contract for one year. Selectman Abbott suggested that we extend this year and start earlier next year. Vote 5-0-0.
- 5. Motion by Selectman Woodsome and seconded by Selectman Littlefield to approve the Junkyard Permit for Laskey. Vote 5-0-0.
