Discuss/vote on Charter Review Commission extension request: The Commission preliminary report states that they have held 14 meetings including a Public Hearing, meeting with the BoS, Administrator, Town Committees and the Town Attorney. Due to a state law that requires 30% of those that voted in last Gubernatorial election vote on the Charter Revision, the Commission requests that they receive a one year extension so that the Charter can be voted on November, 2012. Dennis so moved, Dave seconded. Voted, passed.

Nancy said that they may have to go into an other Special Town Meeting to address the \$66,000. not passed at tonight Special Town Meeting. Dennis states there is projected \$112,000. not spent in all accounts this year. Doug stated that everyone will get different reads on tonight's meeting. He feels people want to know what the Board is going to do as part of their process to ensure it will not happen again. He feels the way Town Hall is run and the biggest piece is the creation of new position to assist the Administrator is a large part of reforming government in trying to handle and help organize.
