Town Administrator Gary Lamb's report was delivered as follows:

Fire truck bid - Our new fire truck bid submissions were due by noon January 2nd. We had five companies express interest in the bid package but unfortunately only one bid was received. That bid was from Greenwood Emergency Vehicles and was

- \$493,663. Chief Bors examined the bid in detail and we decided to accept their \$25,000 trade-in offer for our old truck so the financed amount will be slightly less than the \$493K bid price. We are pursuing financing arrangements since the voters have approved up to a \$500K purchase price and we will move forward with this purchase. The new truck should be here by Christmas 2019.
- Fire station roof update Williams Roofing Company has completed the metal roof panels, all the fascia, the snow guards and most of the outside cleanup for our Central Station Roof replacement. We still have some final cleanup and punch list items to discuss with them and then we can make our final payment to them. On cold days just after a snowstorm notice how long the snow stays on the metal roof. That tells us the insulation is doing its job and the roof is not being warmed from heat loss below. This will save some taxpayer dollars on heating costs.
- Rehab bus sold Our Fire Department rehab bus will not pass inspection because of structural rust. We put it out to bid again....this time without the \$1500.00 minimum bid criteria. We received one bid from CIA Salvage for \$1,011.00....so we will sell it to them.
- ▶ Plowing contractor update Some complaints during the last storm were that some side street developments were not plowed at all until the snow stopped around mid-morning...even though our trucks were out by 3 a.m. that day. Their drivers thought it was OK to leave the side streets until the small storm had stopped. DPW Director Benton made it abundantly clear to the contractor that is not OK for Waterboro roads. Our contract states plows must run when ice buildup is occurring or 2 inches of snow accumulates...and that is what we expect will happen in the future.
- Winter Blues? Save up your winter blues and know we are already finalizing musical acts for the 2nd Annual York County Blues festival Saturday, August 24th in Friendship Park!!
- <u>Budget Committee</u> The Budget Committee has started its meetings and will meet on Mondays at 4:30 p.m. If a Monday is a holiday, they will meet on Thursdays. The meetings will be recorded if anyone wants to view them.
