a. Selectmen's reports

Dwayne Woodsome commented that they had a good meeting with officials from RSU#57 last Thursday. The meeting was well attended by some officials from all six RSU towns.

Tim Neill commented on the upcoming Library Silent Auction that begins on April 1, 2019. Items for bid can be seen on the Library's Facebook page.

Dennis Abbott reported that he attended the ecomaine meeting last Thursday. The ecomaine Budget Committee is preparing the budget for voting.

b. Town Administrator Gary Lamb's report

Town Administrator Gary Lamb's report was delivered as follows:

- ▶ Budget update A Board of Selectmen budget workshop with the entire Budget Committee was held March 19th in Town Hall. The entire municipal budget was reviewed over the two hour meeting but no Selectmen decisions were made. Selectmen can finalize their budget recommendations at the March 26th (or Sat March 30th or April 2nd extra meetings if needed). The June 11 election warrant needs to be signed on or before April 11th...so April 9th will be the absolutely last Selectmen voting meeting before finalizing the warrant.
- Elections Nomination papers for Selectman, Water District and School Board were available March 13th ...and are due back by 5 p.m. April 26th. So far we have nomination papers out with three interested in two open Selectmen seats with one set filled out and returned. The top two vote tallies on June 11th will be the winners of these Selectmen's seats. We have two sets of papers out for Water District; and only one set of papers out for two school board open seats. Since it appears we may have competition at least for Selectmen seats, I did confirm that our former moderator Bob Powers is willing to moderate a candidate's night in mid to late May.
- Ossipee Lake Dam operator needed Our long time dam operator Don Holden has informed me he wants to be done with his Ossipee Lake dam and water level duties before Memorial Weekend 2019. He does have at least one citizen interested in taking over whose name will be forwarded to Selectmen. The Board should not only think about replacing Don but also whether or not a stipend should be added to the FY 19/20 budget. Don was unpaid all these years and did a great job keeping the lake levels consistent, even when working around major storms and all manner of mother nature's challenges. If Selectmen want a stipend for this position we should add it to the budget.
- Central Station HVAC bids Bids were solicited for HVAC work at our fire station to inform Selectmen about costs for mini-split heat pumps, in hopes Selectmen would approve the use of unused roof funds (not to exceed \$35K) for this work in this fiscal year. Sealed bids are due into Town Hall by noon Friday March 29th and will be opened at that time.
- ➤ <u>Town Hall fireproof records room update</u> Bids for the creation of this fireproof room addition onto the CEO's existing office are due by 11a.m. Friday March 29th and will be opened at that time.

Gordon Littlefield made a motion to reduce the Deputy Town Administrator stipend from \$3,400 to \$1,500. Tim Neill and Gordon Littlefield withdrew their first motion and second respectively. Tim Neill made a motion to approve \$421,055 in the General Government Budget. Gordon Littlefield seconded. The motion passed 5-0.

Ted Doyle made a motion to approve the **Leases/Debt Service budget for \$309,154**. Gordon Littlefield seconded. The motion passed 5-0.

Gordon Littlefield made a motion to approve the **Insurances/Benefits budget for \$653,625.** Tim Neill seconded. The motion passed 5-0.

Dwayne Woodsome made a motion to approve the **Town Clerk budget for \$64,830.** Gordon Littlefield seconded. The motion passed 5-0

Dwayne Woodsome made a motion to approve the **Tax Collector budget for \$44,370.** Tim Neill seconded. The motion passed 5-0.

Ted Doyle made a made a motion to approve the **Public Safety budget for \$1,062,684.** Tim Neill seconded. The motion passed 5-0.

Gordon Littlefield made a made a motion to approve the **Hydrant Rental budget for \$59,700.** Ted Doyle seconded. The motion passed 5-0.

Dwayne Woodsome made a made a motion to approve the Ross Corner Fire Company budget for \$9,987. Gordon Littlefield seconded. The motion passed 5-0.

The Board of Selectmen postponed the Health and Sanitation budget which will be discussed at a special Selectmen's meeting on April 2, 2019 at 5:00 p.m.

Tim Neill made a made a motion to approve the **Public Works budget for \$1,504,090.** Gordon Littlefield seconded. The motion passed 5-0. The Selectmen requested that line 429, Hot Top description be changed to *up to 4.5 miles*.

Tim Neill made a made a motion to approve the **General Assistance budget for \$47,591**. Gordon Littlefield seconded. The motion passed 5-0.

The Board of Selectmen postponed the Capital Improvement Programs budget which will be discussed at a special Selectmen's meeting on April 2, 2019 at 5:00 p.m.

Ted Doyle made a made a motion to approve the **Unclassified Budget for \$656,183.** Gordon Littlefield seconded. The motion passed 5-0. \$6,500 was added for Board and Committee stipends.

Ted Doyle made a made a motion to approve the **Old Home Days budget for \$25,000.** Gordon Littlefield seconded. The motion passed 4-1 (Woodsome opposed).
