Erika McKay made a brief presentation on the 2019 audit. She reported that as of June 30, 2019 there was \$5.2 million in assets with \$539,000 in liabilities and obligations, leaving \$4.2 million in fund balance. \$1.6 million of this amount is undesignated. The Town is fiscally sound and Ron Smith suggested establishing a calculated capital reserve plan and show the crisis fund separate from the general fund.

Gordon Littlefield commented that the Community Center Steering Committee is sending letters out to people that own large parcels of land to solicit interest in donating 10 plus acres to the Town for a community center. He also explained the components the building would include. The Committee will be interviewing an architect next Monday.

b. Town Administrator Gary Lamb's report

Town Administrator Gary Lamb's report was delivered as follows:

- Recent storm update Last week's storm was long and had mixed reviews on plowing. Some new plow contractor drivers need to work on more frequent plowing of smaller subdivisions...and not hitting mailboxes. DPW staff will continue to work on these issues with our contractor Paul Poirier of Dayton Snow Fighters.
- Election polling place update I have spoken with Sanford School Superintendent Matt Nelson in regards to a regional or statewide aspect to schools as polling places...and schools possibly being closed during elections. He is in communication with RSU 57 Superintendent Larry Malone and others on this issue...but has no specific new information at this time. He is aware that numerous other towns also would be helped if they could use schools for elections without students present. Stay tuned for more information as I hope to have an answer from RSU 57 by end of February at the latest.
- Community Center Steering Committee update This committee met last night to discuss the seven bids for preliminary architectural services not-to-exceed \$25K. This project is for preliminary concept drawings we can take to the public for discussion on whether or not to build a new community center that could consist of a new library, basketball gym, recreation program space, and multipurpose space for our polling place and community meetings and suppers. All bids were between \$24,000 and \$25,000. They decided to interview two firms on either December 16th or January 6th. Once these concept drawings are completed in late winter, then open public meetings can be scheduled in spring/summer for greater public input into this idea.
