Transfer Station

Josh will be implementing some new safety procedures for staff when using the loader/backhoe in and around the containers. This will provide additional protection for staff and customers

<u>DPW</u>

Pete Smith indicated the Parks Committee has been working on improvements at Friendship Park. They coordinated the removal of the hazardous trees. He will follow up to see when the partially cut tree and debris will be removed.

I've asked Pete Smith to follow up with and move forward with the siding replacement at the Old Town Hall, we need to put this RFP/Bid out ASAP.
