2. PUBLIC HEARINGS

a. Amendment to the Parks & Recreation Spaces Ordinance MRSA 30 §3009

Chairman Abbott opened the Public Hearing on the Parks & Recreation Spaces Ordinance amendment at 6:07 p.m. with the reading of what the Amendments will be to this ordinance. The amendments to the Ordinance are to add section 1.01.17, "Ice Shacks shall not be located or stored within the park area prior to January 1st and must be removed by April 1st. - b. Interim Town Administrator Matt Bors report:

Reminded everyone to continue to push TextMyGov services so we can continue to build our data base. This service is used to reach a lot of residents quickly with important information.

Public Works Director and driver-Laborer positions have been posted. Matt and Jason Champion will be discussing the applications they have received. The ad for the position has been updated to say that interviews will begin immediately and the position will remain open until filled.

Thank you to Selectman Dwayne Woodsome who has helped out these last few weeks with the transition of Public Works. Jason Champion has been well involved and we are off to a good start and we will continue to work with him and hopefully have a seamless transition.

The lights at Hannaford have not been working. We have had an electric light out. A bad loop has been found. The estimated repair for this is \$6,000 and the state does not have ownership or plan to take over the ownership of these lights. Matt is going to be following up with the Traffic Engineer from Southern Maine.

Regarding current staffing levels, we may want to contract out the maintenance and mowing for our parks and the monument. We have currently used staff but it takes them away from their current positions.

Contract from Southern Maine Planning & Development—We have received the current contract for Planning assistance which should have started Feb. 1. Matt asked the Board if they planned on hiring a FT planner or if he wanted him to sign the contract. Chairman Abbott stated that Matt should go ahead and sign the contract as a FT Planner position has not been filled.

Ten abutters to the property for Agenda Item #10a attended the meeting.

Michael Provencher made a motion to move Agenda Item #10a- Old Business - Discuss/vote on a consent agreement for Map 24 Lot 20, up ahead of New Business. Dwayne Woodsome seconded the motion. The motion passed 5-0.

Code Enforcement Officer Michael Gilpatrick went over the violations that previously have gone before the Board of the severe cutting of trees down on the property located on Map 24 Lot 20. The homeowner has replanted some trees but they do not meet Shoreland Zoning guidelines. He has also put up three pressure treated walls that do not meet Shoreland mandatory setbacks. The homeowner is required to come up with a revegitation plan by April 1 2022 and it needs to be professionally installed. There was much discussion and some of the abutters spoke on the extreme damage that has been done and that the fine in the consent agreement

that is being discussed and voted on today does not meet the crime. Chairman Abbott thanked the abutters for their input.

David Chauvette made a motion to approve of an amended consent agreement with the removal of the waiving of the fine and adding a fine of \$5,000 along with compensation for \$3600 in legal fees. Dwayne Woodsome seconded the motion. The motion passed 5 – 0.

Ben McCall attorney for the Town will be making the amendment to the consent agreement and if signed by the homeowner he will have it registered at York County Registry.
