Chairman Abbott also stated that the end date to file for LD290, the Tax Stabilization act, is December 1, 2022 and not December 31, 2022. You have to renew this application every year and it is for residents who are age 65 or older and have at least 10 years of homestead exemptions.

## 8. REPORTS & STAFF INITIATIVES:

#### a. Selectmen's reports:

Dwayne Woodsome – said that he felt the Election ran very well on November 8<sup>th</sup>.

## b. Town Administrator Matt Bors report:

#### General Information:

- Marina has provided information regarding the elections last week.
  - 59% voter turnout
  - We used all our election day ballots and needed to use the extra absentee ballots due to the shortage
  - Solid lines a majority of the day
  - o Greatly appreciate all the workers who helped! Much appreciated.

• We are trying hard to get the parts for the boiler at the Library. Unfortunately, we must wait for the parts to arrive. At this point the library will have limited services until the repairs have been completed. Jason and I have been discussing other potential alternatives just in case. The estimated cost to repair is \$3,000.

• While I was out last week, our boiler at the fire station was scheduled for a repair of a pressure relief valve. When they were servicing the unit, they found the main chamber was also cracked. We are currently working on plans for a replacement. The Estimated cost of repair is \$10,000.

• Our DPW Director had the road painting scheduled, however at the last minute the vendor had mechanical issues and had to cancel. Jason will continue to communicate with them and hopefully get the recently paved roads marked soon.

• Work has been underway with our audit for this past FY and we have already started our budget planning for the next FY. We will begin meeting with the budget committee in January.

• Previously we had discussed the purchased of a cruiser (approved within current budget). Our request had been for a patrol truck used similarly by the state police and other sheriff's departments across Maine, however YCSO and the County Manager did not want to utilize a truck. Chief Deputy Forbes has provided the hourly rate for the spare cruiser we have been using. They would charge \$10.00 per hour plus fuel. This would cost almost 21K a year. At this point, based on the initial estimates I would propose we move forward with securing a replacement vehicle which will have a greater ROI.

David Chauvette made a motion to accept the resignation of Lisa Moulton from the Garden Committee. Michael Provencher seconded the motion. The motion passed 5 – 0.

d. Discuss/vote to update Select Board Liaisons to Committees list

Dwayne Woodsome made a motion to remove Michael Provencher as the Liaison to the Olde Home Days committee and to appoint Gary Fecteau as the Liaison. Michael Provencher seconded the motion. The motion passed 5 - 0.

e. Discuss/vote to approve the Eagles #492 Games of Chance renewal application

Dwayne Woodsome made a motion to approve the renewal application of Games of Chance for the Eagles. David Chauvette seconded the motion. The motion passed 4 - 0. Michael Provencher abstained from voting.

The cruiser was approved at the June Election. During the September 20, 2022 Select Board meeting, the Board voted to sign the YSCO contract but not to purchase a new police cruiser. Since then, Chief Deputy Forbes has provided the hourly rate for the spare cruiser we have been using. They would charge 10.00 per

hour plus fuel. This would cost almost 21K a year. At this point, based on the initial estimates it would be better if we move forward with securing a replacement vehicle which will have a greater return on investment.

Dwayne Woodsome made a motion to reconsider the motion from September 20<sup>th</sup> under Old Business #10A with regards to the YCSO Deputies Contract. Gary Fecteau seconded the motion. The motion passed 4 - 0 with David Chauvette abstaining.

Dwayne Woodsome made a motion that we consider buying the police cruiser that was budgeted for and for the purchase not to exceed \$40,000. Michael Provencher seconded the motion. The motion passed 4 - 0 with David Chauvette abstaining.
