# Mintues for Waterboro Board of Selectmen Meeting March 21, 2023, at Waterboro Town Hall 5:30 p.m. Workshop - 6:00 p.m. Regular Meeting

## 5:30 p.m. Workshop with Water District to discuss economic impact of district to Waterboro:

Three members of the Select Board; Chairman Abbott, Dwayne Woodsome, and Gary Fecteau, along with Administrator Matt Bors met with the Water District Board of Trustees and Staff. The Town has had a few projects come to the Planning Board that were told they cannot be serviced by the Water District at this time and this has concerned the Select Board. It was explained by the Water District that this was due to their main water supply well on Straw Mill Brook Road failing so they were just trying to maintain their current customers. This well since has been fixed and it is being monitored. To date the well has recovered to 48 gallons per minute. The District is looking into exploration grants to look for a new production well. The Town understands the Water Districts struggles and is looking to continue a strong relationship with the District.

<u>Vote:</u> Dwayne Woodsome made a motion to appoint Marina Gagne as Voter Registrar and Nancy StAmand as Deputy Voter Registrar. Gary Fecteau seconded the motion. The motion passed 3 – 0.

## c. Discuss/vote to accept Michael Provencher's resignation from the Select Board

<u>Vote:</u> Gary Fecteau made a motion to accept Michael Provencher's letter of resignation from the Select Board dated March 13, 2023, with an effective date of June 13, 2023, at 11:59 p.m. Dwayne Woodsome seconded the motion. The motion passed 3 - 0.

<u>Vote:</u> Gary Fecteau made a motion to include this vacancy of the Select Board on the June  $13^{\circ}$  2023 Municipal Election. Dwayne Woodsome seconded the motion. The motion passed 3 - 0.

<u>Vote:</u> Gary Fecteau made a motion to reduce the nomination period by 7 days for this vacancy only with a due date of signatures remaining as May 1, 2023. Dwayne Woodsome seconded the motion. The motion passed 3-0.

This third vote was needed to be done because the date of the resignation. The time frame for someone to get papers out is shy seven days as of today.

## d. Discuss/possible vote on Draft Audit

The final audit was received after the agenda was set.

<u>Vote:</u> Dwayne Woodsome made a motion to accept the Final Audit for Fiscal Year 2022. Gary Fecteau seconded the motion. The motion passed 3 - 0.

#### a. Discuss/vote to approve the Special Amusement Permit for 38 West Pub & Grille

This item was voted on after the public hearing to be moved up before announcements.

## b. Update on Map 3 Lot 55

There was some discussion on what the Select Board wanted to do with this property. They can hold a public auction, sell it by sealed bid, or have a realtor sell it for the Town. Matt stated that Natalie does not recommend us assigning a minimum bid if it goes to public auction The Board decided on selling the property by sealed bid. They want the abutters to be notified of their intentions.

<u>Vote:</u> Gary Fecteau made a motion that Map 3 Lot 55 be put out to the public to bid by sealed bid with a closing date of May 2, 2023, at 5:00 p.m. Dwayne Woodsome seconded the motion. The motion passed 3-0.

# c. Discuss updated Tax Acquired Properties List from Christine Torno:

Chairman Abbott recommended that the Board set up a series of discussions with the property owners of the potentially sellable properties to find out why taxes have not been paid. It was decided that the properties that have structures on them would be the properties considered for sale.

<u>Vote:</u> Gary Fecteau made a motion that out of the list received of the tax acquired properties, that the properties that are inhabited, the Board gives these owners opportunity to come speak to the Board of why there taxes are in arrears. Dwayne Woodsome seconded the motion. The motion passed 3-0.

The Board decided that April 18<sup>th</sup> these property owners will have to meet with the Select Board by.
