
## Minutes for Waterboro Board of Selectmen Meeting December 5, 2023, at Waterboro Town Hall 5:00 p.m. Workshop - 6:00 p.m. Regular Meeting

# Workshop - 5:00 p.m. - Regarding DPW Garage:

Workshop Attendance Select Board: All Select Board members were present except David Chauvettte. Other Attendees: Matt Bors, Jason Champion, Michael Gilpatrick, David Lowe, Glenn Seehagen, and Laura Lowe.

The workshop started at 5:11 pm. The below building sketch was presented by Jason Champion, DPW Director, to the Select Board for the proposed DPW Garage. This building will benefit the Town for the future so we can take over the plowing from our current plowing contractor which is currently charging us \$728,000 for this fiscal year and will increase 2% the next two years. The price for the two year additional contract option was not priced. The building will also house a Town mechanic which will help with our Town wide vehicle and equipment repairs. The below building has three different options with payment amounts in case the Board wants to do the building in stages: Main Building (Base) \$2,596,000, Option 1 - Offices, storage, and break room \$624,840, and Option 2 – Lean-to \$100,000. The total proposed building cost is \$3, 320,840. The location of the building will be right on Bennett Hill Road right before the Transfer Station & DPW entrance. There was some discussion on adding a generator by saving money in a different area. The Board agreed that the next step for the building is to contact a surveyor and to explore financing options. Then the voters will have to decide in June if it is approved through the Budget process. Matt will provide the Board with an update on the next steps at the next Board meeting December 19, 2023.

a. Selectmen's reports

**Dwayne Woodsome –** reported that the Planning Board meeting that was scheduled for this evening has been cancelled. However, there is a ZBA hearing tomorrow here at the Town Hall at 6:00 pm.

## b. Town Administrator Matt Bors report General Information:

- We have offered and received an acceptance letter from Amber St. Ours for the Deputy Treasurer position. Amber brings 18 years of municipal experience to Waterboro. Her experience ranges from tax collections, clerk, MV service and Office Manager. She will begin her duties with us January 2.
- Fred Holt continues to work on balancing our checking account. As of yesterday, he is
  now up to July 2023. Although he has found multiple data entry errors, he has been
  correcting as needed. We will continue to keep you updated with his progress. He will
  also be working with Amber on some of the Trio software programs.
- Public Works Director Champion had the shoulders repaired on Old Alfred Road. This will help with the longevity of the paved surface. Thank you Jason.
- We had a complaint regarding some training and safety issues at the Transfer Station. I
  have asked Capt. Fraser (WFD) to assist with our MDOL/BLS safety compliance for ALL
  departments. This involves the creation of written programs, postings, and annual
  training. Some of the programs that we have used at the Fire Department can be
  recreated for the other sites. Our goal is to use the Maine Municipal Association- Online
  University. The training is not optional and will be required by all employees.
- FD and Water District assisted with the ICE Rink this past Saturday. It took a little over 12,000 gallons to fill it.
- We will have funding remaining from ARPA funds. I have a couple of thoughts that I think might be beneficial.

  - Covered Pavilion that can be used during inclement weather by pickle ball users and for seating for Concerts in the Park or maybe ice skating in the winter.
- Victor Wright, President of the Historical Society has requested a workshop with the Board on December 19<sup>th</sup> at 5:30pm.

The Board asked to schedule a workshop with the Historical Society for the next meeting and Matt will see if Victor can come in at 5:00 instead of 5:30 pm as there is already an Executive Session at 5:45 pm that was rescheduled from this meeting.

This is the first time this type of State Application has come to the Board.

<u>Vote:</u> Dwayne Woodsome made a motion to authorize the Select Board Chair to sign the State Application. Gary Fecteau Seconded the motion. The motion passed 4 - 0.
