Report of the Superintendent of Schools

To the Citizens and the Superintending School
Committee:

I herewith submit the annual report of the schools
of Waterboro.

The last school census shows that Waterboro has 285 young people between the ages of five and twenty-one, 148 boys and 137 girls. In previous years the state has used school census figures as one of the factors determining the amount of state money allocated to the various towns. However, the last legislature ended this custom when it passed a law substituting school registration in place of school census.

Elementary registration is 163. South Waterboro registers by grades as follows: Grades 7-8, 38; Grades 4-5-6, 29; Grades 2-3, 22; Grade 1 and Sub-primary, 23. East Waterboro has 20 in the Primary School and 15 in the Intermediate. North Waterboro Primary has 16.

Owing to the crowded condition in the building at South Waterboro it has been necessary to use the assembly hall as a high school classroom. This transfer provided seating space for grades 7 and 8. The problem has thus been temporarily solved, but a continued increase in registration will bring about a very serious situation.

The last legislature also enacted an amendment to the free tuition law. It reads, "Any youth who resides with a parent or guardian in a town that maintains or contracts for school privileges in an approved secondary school which offers less than two occupational courses of study, and whose qualifications for training are approved by the superintending school committee of the town, may elect to attend some other approved secondary school to which he may gain admission for the purpose of studying an occupational course not offered or contracted for by the town of his legal residence." It is further provided under this act that towns paying tuition for such courses shall be reimbursed two-thirds of the amount paid, the total amount of reimbursement not to exceed \$875.00.

The deficit under the Repairs and Equipment Account is partially explained by the fact that last year a bill of \$250.00 for seats for the primary room was not received until after the closing of the town accounts, thus necessitating payment out of this year's funds. There has also been a reduction in the appropriation in the past two years.

Several matters of repair should be attended to during this coming year. A new smoke pipe will be necessary for the boiler in the plant at South Waterboro. Much heat would be conserved by weatherstripping the windows in the assembly hall. The addition of an extra radiator in this room has partially overcome the heating difficulty. New steps should replace the old ones at East Waterboro, and some means of supplying the pupils of this school with suitable drinking water should be provided.

We are indebted to the Waterboro Chapter of the

Red Cross for sponsorship and financial assistance in initiating a hot lunch program for the school children. Through cooperation of a group of mothers this program is already underway at South and East. This project is very much worthwhile and deserves all the support the town can give it.

Among the provisions of the will of the late Rhoda May Carl the sum of one hundred dollars was left as a fund, the income of which is to be used for the purchase of library books for Waterboro High School.

In conclusion I wish to express my appreciation to the citizens, school board, and teachers for their cooperation during the year just ended.

**REPORT OF THE
MAINE PUBLIC HEALTH NURSE**

I herein submit a brief report of service rendered the Town of Waterboro by the York County Tuberculosis and Health Association for the period beginning January 1, 1945 to December 31, 1945.

One of the important objectives of our Health Program is case-finding, prevention and control of tuberculosis. It is a communicable and an infectious disease, caused by the tubercle bacillus, which is found in the discharges from a tuberculous gland, bone or skin sinuses, sputum, gastric or intestinal contents. Finding the case early not only gives an opportunity for cure, but prevents infection to other members of the family and fellow citizens.

In the State of Maine, 12 out of every 1,000 persons were rejected, in World War II, because of tuberculosis. Keeping the armed forces free has added to civilian problems of tuberculosis prevention. However, with complete cooperation with your doctor and health associations every case of tuberculosis will be uncovered so that it may be treated and also protect all persons who have not been infected with the disease. Ask us to arrange for a chest X-ray for you.

Early in the year, 44 students were given patch tests for tuberculosis. All were negative. One 1943 positive reactor was taken to Sanford for re-X-ray of chest.

Many home calls were made to assist parents in

having defects of school children corrected. The local Red Cross furnished finances in several cases for tonsillectomies and dentistry.

The school at North Waterboro is much in need of a victrola, or some musical instrument. They are learning simple theory and doing some very nice work in copying music, etc.

Grades seven and eight at South Waterboro have done unusually good work in two-part singing, as have grades five and six in both South and East schools. New text books are needed for these grades.

The high school was unable to present a Christmas cantata as planned, but are starting on one for Easter to be presented in April. We are taking up some mu-

sical quiz questions, and music appreciation with victrola records kindly loaned by Charles Heffernan and Richard Savage.

I wish to express my appreciation to the Superintendent, School Board, teachers and citizens for their support and cooperation which have contributed so largely to a successful year.

May I extend my personal thanks to Mrs. Natalie Hobbs and Miss Edith Abbott for their work as accompanists during the year, and to Mr. Libby, who has assisted so much in our cantata work.

TREASURER'S STATEMENT

For the twenty-third time I have the great honor of presenting to the voters of Waterboro a statement of the financial transactions of your Treasurer and Collector of Taxes. Notwithstanding the closest check-up, it is submitted subject to the annual audit of the State Department of Audit.

1249 Orders issued by the Selectmen have been paid, all loans made in anticipation of taxes have likewise been paid and we have made the annual payment on account of town bonds of \$2,000.00 and interest on all outstanding bonds to date. Our bonded indebtedness is now \$11,000.00, and this amount represents our every outstanding obligation. It will be remembered that \$29,000.00 was borrowed for the purpose of retiring old notes and school bonds November 1, 1936 and bonds were issued in this amount, payable in the amount of \$2,000.00 and accrued interest yearly.

The Caroline Leonard Funds as of May 18, 1945 were as follows:

Account 23285—For care of graves at Water- boro Center	\$354.36
Account 22913—For Church, Schools and Poor of Old Corner	\$195.35
Account 22912—For Church, Schools and Poor of Waterboro Center	\$629.63

These sums are on deposit in the Biddeford Savings Bank and can be withdrawn only on the order of the three Selectmen accompanied by a certificate that money so drawn shall be used only for the purposes set forth in the original trust agreement.

I am indebted to many for their cooperation in collecting a tax commitment of nearly \$38,000.00, less than 5% of which remains collected to date and of the balance, 75% will probably be collected within three months.

My hearty thanks to every person who has cooperated to make my work successful.

GREETING:

IN THE NAME OF THE STATE OF MAINE, you are commanded to notify and warn the Inhabitants of said Waterboro, qualified to vote in town affairs, to assemble at the town house in said town on Monday, the eleventh day of March, A. D., 1946, at 10 o'clock in the forenoon, then and there to act upon the following articles, to wit:

First: To choose a Moderator to preside at said meeting.

Second: To choose all necessary town officers for the year ensuing.

Third: To see what sum of money the town will grant and raise for the roads and bridges for the year ensuing.

Fourth: To see what sum of money the town will grant and raise for winter roads for the year ensuing.

Fifth: To see what sum of money the town will grant an draise for State Road Patrol.

Sixth: To see what sum of money the town will

raise and grant for Free High School, Common Schools and Text Books and Supplies for the year ensuing.

Seventh: To see what sum of money the town will grant and raise for the Repair of School Buildings for the year ensuing.

Eighth: To see what sum of money the town will grant and raise for the Salary of Superintendent of Schools for the year ensuing.

Ninth: To see what sum of money the town will grant and raise for Public Health Nurse for the year ensuing.

Tenth: To see what sum of money the town will grant and raise for Incidentals and Town Officers' Salaries for the year ensuing.

Eleventh: To see what sum of money the town will grant and raise for State Tax for the year ensuing.

Twelfth: To see what sum of money the town will grant and raise for County Tax for the year ensuing.

Thirteenth: To see what sum of money the town will grant and raise for Interest on Town Bonds for the year ensuing.

Fourteenth: To see if the town will grant and raise the sum of Two Thousand Dollars to retire two town bonds for the year ensuing.

Fifteenth: To see if the town will grant and raise a sum sufficient for the proper observance of Memorial Day.

Sixteenth: To see what sum the town will grant and raise a sum of money to pay Interest on Tax Anticipation notes for the year ensuing.

Sixteenth: To see if the town will vote to grant authority to the Selectmen and Treasurer to borrow money on the credit of said town to pay current bills for the year ensuing.

Eighteenth: To see if the town will authorize the Collector of Taxes to charge interest at the rate of one-half per cent per month on all taxes unpaid September 1, 1946, interest to commence on October 1st.

Nineteenth: To see if the town will grant and raise a sum of money for the cutting of bushes on Unimproved Roads for the year and to see what method the town will vote to adopt in the cutting of the same.

Twentieth: To see what sum of money the town will grant and raise for Maintenance of Third Class Roads for the year ensuing.

Twenty-First: To see if the town will grant and raise a sum sufficient to maintain the present street lighting system and for the installation of any addition street lights, in the judgment of the Selectmen, for the year ensuing.

Twenty-Second: To see if the town will vote to instruct the Selectmen to cause the arrest of all persons who fail to pay their dog taxes prior to May 15, 1946, after first giving such delinquents ten-day notices that complaints would be made under the provisions of Section 161 of Chapter 5 of the Revised Statutes of the State of Maine.

Twenty-Third: To see if the town will grant and

raise a sum of money for the use of the Waterboro Fire Department, and if so, how much.

Twenty-Fourth. To see if the town will grant and raise a sum of money for the further repair of the road leading over Chadbourne's Ridge and, if so, how much.

Twenty-Fifth: To see what sum the town will grant and raise and appropriate for State Aid Road Construction (in addition to the amounts regularly raised for the care of ways, highways and bridges) under the provisions of Section 25 and 29, Chapter 20, R. S., 1944, as amended.

Twenty-Sixth: To see if the town will grant and raise the sum of one hundred dollars to cut bushes on improved sections of Third Class Road locations.

Twenty-Seventh: To see if the town will vote to grant and raise a sum of money for the repair of the road from H. P. Hamilton residence to Lyman line, and, if so, how much.

Twenty-Eighth: To see if the town will vote to grant and raise the heretofore voted sum of twelve hundred and fifty dollars for a town memorial and to see if the town will vote a sum yearly for its future maintenance.

Twenty-Ninth: To transact any other business that may lawfully come before said meeting.
