Born October 7, 1885 -- Died June 27, 1946



In the death of Frank A. Walker, Waterboro lost one of its most popular citizens and one of its most capable and efficient town officials. He served as Road Commissioner from 1918 to the date of his death, with the exception of one year. He was born in Waterboro, attended the grade schools and was a graduate of the Waterboro High School. As a vote-getter, he was almost unbeatable in those days when partizanship was a great factor in March meetings. He was a good citizen and will be long remembered as one of our most outstanding town officials.

REPORT OF FOREST FIRE WARDEN

The purpose of the new Slash and Fire Laws, which became effective August 6, 1949, was to place forest fire control under the Forestry Department of the State. It provides an unbroken chain of command from the town forest fire warden to the forest commissioner. A maximum amount of authority remains with each local community, but state authority is provided whenever the town system breaks down.

The town forest fire warden is appointed by the fire commissioner with the approval of the local town

officials for a three year term. Under the law, "The management of town forest fires shall be the responsibility of the town forest fire warden until in the judgment of a state forest warden the situation makes it advisable for him to take over". Local towermen are directly responsible to the state wardens, but cooperate with the local fire warden.

Burning permits: It is unlawful for any person to kindle a fire for purposes of clearing land, or burning logs or stumps, roots, brush, slash, fields of dry grass, pasture and blueberry land except when the ground is covered with snow, without first obtaining a permit. Permits are issued by the town forest fire warden. A permit is necessary for any person to burn, even on his own land.

The cooperation of all citizens is desired in order that there shall never be a repetition of the great disaster of 1947.

Report of the SELECTMEN

On the preceding pages will be found an itemized statement of all departments during the year 1949, with one exception, namely, that of the Superintendent of Schools. His report has been carefully checked with our records and found to be correct, and the same appears in the pages following in this volume.

Likewise, all receipts by the Treasurer and Collector have been carefully checked and agree with ours in all respects.

For the first time since 1921, the Town of Waterboro is completely free from debt. All bills have been paid for 1949 work and it is our intention to continue this happy condition.

We have been able to fix the tax rate at the lowest point for many years, thanks to the extreme generosity of the State of Maine and its 94th Legislature which gave us a grant of \$15,000.00 for 1945 and a like amount for the year 1950. These sums were given us to take the place of lost inventory because of the 1947 fires, and if wisely used for this purpose, will be helpful to our taxpayers for many years. The wealth of Waterboro was in its trees that grew abundantly everywhere, but which were destroyed by the merciless fire and the salvage operations that followed necessarily. Already, the State has commenced to reforest areas

in the Towns of Shapleigh and Newfield, both of which border us, and we are hopeful that the process will be extended to the western sections of the town, that part most seriously damaged.

There is another topic that deserves serious attention. The law requires that everybody owning or harboring a dog must pay an annual tax. Our experience has shown that there are those who pay only after numerous notices and threats. We intend during the coming year to cause an enforcement of this law by June 1st. No dog owner should receive the least sympathy hereafter if brought into court and compelled to pay fine and costs after being given proper notice.

One other matter that deserves serious attention is that regarding real estate owners who in the past have been delinquent regarding the payment of taxes. In each and every instance of delinquency, the Collector of taxes has been compelled to file liens against such real estate in the Registry of Deeds. Any owner, and every purchaser, before conveying real estate should make sure that all taxes are paid and liens, if any, are discharged, else when this town moves to collect those delinquent taxes, AND IF WILL MOVE BEFORE LONG, former, and new, owners will find themselves in a situation that will cost, not only the delinquent taxes, but large costs, or the danger of a complete loss of the property.

To those persons delinquent because of non-payment of personal and poll taxes, notice is now given that in road work, preference will be given to those delinquent and the Treasurer will be given authority to deduct from road checks these delinquent amounts.

The "bookkeeping" for the year 1949 has been attended to by the present Board of Selectmen, and for

which work no extra charge has been made. Payments in the past have varied from \$50.00 to approximately \$200.00 for this work, and work on the book of inventory, which has cost the town approximately \$35.00 annually in the past, no extra charge has been made.

TREASURER'S COMMENTS

An examination of the accompanying report, which sets forth the "come and go" of cash through the Treasurer's office for the year ending February 1, 1950 will reveal that Mr. Ernest G. Knights, who so well served this town in the dual capacity of treasurer and collector for over a quarter of a century, turned over to his successor funds in the amount of \$13,578.51 under date of March 21, 1949.

Said successor desires to go on record as being "fully satisfied and content" with the sum received and is glad to take this opportunity to express appreciation for the assistance and cooperation which Mr. Knights has stood ready to render on any and all occasions. The records of his office have been available at all times and his experience has added weight to their value.

It will be noted that the items entered in the report are, for the most part, self-explanatory. During the months of June and August it was necessary to borrow a total of \$13,000.00 from Springvale National Bank on Tax Anticipation notes but (as the report shows) the town received \$15,000.00 from the State Treasurer (on August 20) and it was therefore possible to cancel this indebtedness with the issue of Warrant No. 14 on August 27.

Attention is called to the fact that the assistance which we have received from the State of Maine has been well-nigh invaluable: It has enabled us to cast our tax at the low rate of \$50.00 and still have avail-

able funds from which to meet current expenses in excess of current income. It has also enabled us to cancel all outstanding obligations including the last of the Town Bonds which were due on November 1, 1950 but which were retired at a small premium on February 1, 1950. A letter from Mr. Leland Powers of Boston, printed as a part of this report, will be of interest to all. For the first time in nearly thirty years, the Town of Waterboro is out of debt. Let us resolve that it shall so remain for a long time to come.

COLLECTOR'S COMMENTS

The foregoing statement and schedules reflect the results of the activity of the Collector's office for the year ending February 1, 1950. They are presented in the hope that everyone interested will give them careful attention.

All will understand that the tax rate of \$50.00 per \$1,000.00 valuation has been made possible solely through the use of granted State funds to cover current expenses in excess of current income. In the absence of such State assistance, the Waterboro rate might well have settled at \$65.00 per \$1,000.00.

It is gratifying to note that Abatements were held to approximately 1% of the Commitment, and that the total of the Delinquent list amounts to but 6% of the Commitment. Further examination will reveal that only 2% of the Delinquency applies to residents of Waterboro. This signifies that local people recognize and take seriously their tax obligation and have this year, in the face of obstacles, written a record of which all may well be proud. Non-residents, generally, are to be commended for their cooperation which is evidenced by a discharge of 90% of their taxes assessed.

**REPORT OF THE
PUBLIC HEALTH NURSE**

I hereby submit a brief report of service rendered the Town of Waterboro by the York County Tuberculosis and Health Association for the period beginning January 1, 1949 to December 31, 1949.

A School Health program has been conducted in all sections of the town throughout the year. This means establishing habits which provide healthful living in the school, the home and the community; and providing knowledge and preventive measures which assist each individual in developing and maintaining good physical and mental health.

In further detail the program consists of checking up on vision, hearing, making a general examination of each pupil, taking heights, weights, special attention to teeth and throat, charting all findings, making recommendations for remedial corrections, visiting and assisting parents of children who are found in need of immediate medical and dental attention.

A Tuberculosis Case-finding program which consists of tuberculin patch testing of the school children, X-raying all adult contacts of positive reactors and follow-up of all known cases and contacts.

Also organizing and conducting immunization clinics for both children and adults.

In May and June, 26 school children were transported by nurse, Mrs. Johnson, a School Board member and parents to Sanford, where they were given a thorough physical examination by Dr. Richards. These examinations were financed by the local Red Cross. Arrangements were made and transportation was furnished by nurse for two of the four recommended for tonsillectomies, and they had tonsil and adenoid operations in Sanford hospital, in July, by Dr. Richards, financed by the Hospital Auxiliary. Some others had, as were recommended, further special examinations by oculists, orthopedic and own family physicians for treatments and follow-up.

Several adults had chest X-rays at State Diagnostic clinic held in Biddeford.

Several special examinations were made in the classrooms because of skin diseases and pediculi. Home visits and adjustments were readily made.

Close teamwork on part of physician, nurse, teacher and parents can be mutually helpful and beneficial to school, home and community, keeps health status at a high level.

In closing I wish to thank the Superintendent of Schools, Mr. Wright, teachers, local Red Cross and individuals for their cooperation and assistance given in conducting the health program this year.

**REPORT OF THE
SUPERINTENDENT OF SCHOOLS**

Citizens of Waterboro:

The report of schools for the year 1949-1950 is herewith submitted.

There is this year a registration of one hundred seventy-eight pupils and they are enrolled in the various schools as follows: South Waterboro grades 7 and 8, 34; grades 4, 5 and 6, 28; grades 2 and 3, 20; sub-primary and grade 1, 29. At East Waterboro there are 31 in the primary school and 18 in the intermediate. North Waterboro has an enrollment of 14.

At the close of the school year in June the two high school teachers resigned, Mr. Stanley M. Libby, principal and Mrs. Mary F. Ricker, assistant. The principalship was filled by the election of Mr. Elmer S. Marshall, a former principal of Waterboro High School. Miss Patricia R. Miller of Portland was elected to the place of assistant. The list of elementary teachers remains the same as of the previous year. We are still without a music supervisor. Unsuccessful efforts have been made to solve this problem. Our only hope is to form a combination with other towns but as yet we have been unable to make such arrangements.

During the year much needed repairs and improvements of school property were made. The exterior of the building at South Waterboro was painted. The rooms and the corridor on the first floor were redecorated in attractive colors. This called for a greater expenditure of funds than was anticipated. The reason for this was that the plaster in many places was

found to be dangerously loose and had to be repaired before any painting could be done. In all probability the same condition exists on the second floor which needs renovation. New window shades were purchased for some of the class rooms. The boiler which has been giving ineffective service for some time was taken down and thoroughly cleaned and repaired. The result is a very efficient heating unit.

The State Department of Health and Welfare last year condemned the water at East Waterboro for school use. To meet this emergency an artesian well was drilled and a new pump installed. Water from this source has passed a satisfactory test.

Waterboro has for some years maintained a three-point system of consolidation. The third point of consolidation, the building at North Waterboro should not be neglected. This building could be modernized in respect to heating, lighting, and sanitation facilities without too much expense.

Waterboro has always been generous in allocation of funds to its schools. Its citizens know, to quote one of our great generals, that "The strength and backbone of our democracy is an informed electorate. We Americans achieve this strength through widespread public education—education which prepares the citizenry for active participation, and simultaneously assures their liberty."

I am very grateful to all for their cooperation during the year.

I herewith submit the annual report of Waterboro High School.

At the opening of school in September, we had a registration of about forty. As is usually the case, some have dropped out and now our registration is thirty-four, divided by classes as follows:

Sophomores	6
Freshmen	9

Activities of the school so far have been of the usual order. The public reception given the entering class early in the fall, sponsored by the Junior class, and several money raising activities by the Senior class.

The objective of the Senior class is a trip to New York and Washington at the close of the school year. We trust that they may raise sufficient funds to finance the trip.

A magazine selling drive was held for the purpose of raising money for athletics and athletic equipment.

As a member of the Central York County League we participate in quite a number of league events. These consist of the usual team activities such as baseball, basketball and track, also public speaking, spell-

ing, horseshoe pitching, checkers and so forth. Much interest is shown in these events and we feel that they are very much worthwhile.

In two of the subjects offered next year—biology and physics—quite a lot of new equipment will be needed.

Our course of study and the subjects offered, have been in exact accordance with State Department of Education requirements.

We are again having the noon lunch program and the entire program is being handled very efficiently.

We are planning a school exhibition to be held some time during the spring term and we trust that the citizens of the town and all friends of the school will find it possible to make us a visit.

In closing, I wish to express my deep appreciation of the support given me by all school and town officials, and also of the friendly welcome and cooperation of the citizens of Waterboro on my return as High School principal.
