MINUTES

Nov. 10, 1981

ROADS

Selectman Woodsome called Limerick Selectman Chamberlain in regards to holding a Special Town Meeting to raise monies for the construction of Ledgemere Bridge. Chamberlain to get back with a date and both Town's hold their meetings on the same date.

List of SAD #57 school bus turn-aroundss received. Copies to be sent to the Rd.Comm. and Snow removal contractors.

Letter to go to Merton Brackett Division Engineer inviting him to attend a Selectman's meeting to discuss the plowing of State Aid Roads in Waterboro.

Selectmen asked Rd.Comm. Bean to install the "No Parking" signs on Pine Drive. Also was asked to deliver the wood to two General Assistance cases.

Bean said he had the Dup road done into the Transfer Station site.

Selectman Woodsome said he had reviewed the roads on the Southern Section of Town with D.Foglio and that at the end of Sand Crossing Road a bulldozer should go in and scoop the area out to make a better turn around. Star Hill Rd. needs to be brushed out along the sides. Roberts Ridge Rd. boulders to be removed from side of road by the new pole line.

Bean asked the status of the Ossipee Hill road construction and Selectmen said they had a meeting set up with abutting property owners to discuss the Town taking some of their property along the road.

Doug Foglio informed Rd.Comm. Bean that he (Foglio) had a culvert down at his house that he had borrowed from the former Road Commissioner. Culvert size 15"X12". He would like a culvert placed on the upper end of the West Shore Rd., but does not feel the job warrants a culvert as large as the one he has. Rd.Comm. to check on this.

Foglio had been asked by the Selectmen to set a price on plowing 250' of the Knight's Rd. The price set at \$250.00, agreed to by the Selectmen.

Plowing Pine Drive discussed, Foglio said he had thought over what he was going to use for equipment to plow the road and had decided on his Michigan. A property owner on Pine Drive had offered her driveway to turn in as long as a 10 wheeler was not used. He said he would do the best he could to keep Pine Drive plowed.

Foglio told Selectmen that signs had been placed on all secondary roads, bounding Waterboro and Lyman. Selectmen told him to have the Town of Lyman submit a bill for half the cost to the Town of Waterboro.

TOWN DUMP

Land Use Consultants to be called for more diffinet marks to be set for boundary lines at the Transfer and Stump Dump sites. Rd. Comm. Bean said a cement retaining wall is up and that he would complete the Stump Dump, cut, stump and scoop out for the price of \$2,000. He was given the go ahead to do the project, for that amount. If fill is needed use the fill across the road.


Closing Roads:
