

MINUTES

Nov.13,1984 Selectmen's Meeting

Present: Chmn. Robert Fay, Dennis Abbott, Andrew Woodsome, Jr, Glenn Bean, Rd.Comm and Jean Chick.

Roads: Selectman Woodsome asked Rd.Comm.Bean if he had placed the culvert in up by the No. Waterboro Fire Barn as the Board had requested approximately three months ago. Bean said that he had not, as yet, but this would be his next project. The stockpile work was discussed and Bean said that he had overspent the account and had not as yet paid himself for the sand used.

Finance Committee: John Monteith ,Chairman will be sent a letter notifying him of the requests received in this office and also letters will be sent to the various committees requesting a preliminary budget be sent to this office by Dec.1,1984.

Planning Board: The Planning Board will have Atty.Roger Elliott at their meeting tomorrow night and have asked that the Selectmen attend. Abbott and Woodsome will attend,Fay may attend but will be late. Selectman Abbott asked that a letter be sent to the Planning Board requesting that all future billing received from Lesley Hammond for work she had performed be signed by the Planning Board before submitting it to the Selectmen for payment. Chairman Fay will write the letter.

Brenda Drown: Mrs. Drown wishes to meet with the Board to discuss doing the Town's tax billing next year. Mrs. Drown plans on starting a computer business in her home. Mrs. Drown will be on the Nov.20th. agenda for 7:30 PM.

Banks: In an effort to secure a Bank within the Town , Chairman Fay will write letters to be sent to the various Banks in this area.

Lighting,CMP: Selectman Woodsome made a motion that within the next year the Town increase the lighting in the South Waterboro Square , seconded by Abbott. Woodsome also made the motion to disconnect the light by the North Waterboro Parsonage, this motion received no second. Abbott moved that the Board have a study done and that he would volunteer to accompany the CMP representative doing the study.The decision of the Board on this was in the affirmative. Selectman Woodsome requested that a in office survey be done to determine the rate increases for this year.

Regional Waste Systems:An Agreement received by the Town needing the signature of the Chairman of the Board was discussed and the Board will refrain from signing this Agreement until further discussion and the Chairman of the Board will write a letter asking that the Town be allowed to vote.

Gun Permit Renewals: In the past all Permit renewals were signed with out a check done through the York County Sheriff's Dept. Chairman Fay made the motion that all permit requests new or renwals be checked throught the Y.C.S.D. before signing. Seconded by Abbott,unanimously passed.

Holiday Hours: Chmn. Fay made the motion to meet on Dec.26th. and Jan. 2nd. as Christmas and New Years day falls on Tuesday, seconded by Abbott,unanimous.

Selectman Abbott made the motion that the Treasurer be notified that no payment shall be made to the Snow Plowing Contractor's for their January payment until after the first of the year. Woodsome seconded. Unanimous.
