PLANNING BOARD:

Larry Jacobsen and Dwayne Woodsome reported that they are presently working on 3 sub divisions;  
1. 49 lots  
2. 36 lots  
3. 35 lots.

A question was raised by Sel Fay concerning the ground water admendment that (after T.M. approval) will be added to the Sub Division Regulation Book. He asked if the Sub Divisions that are already in the "works" will have to comply with this new admendment.

Dwayne Woodsome said he was not sure at this point if they would be required to submit a ground water study or if their sub divisions would be grandfathered. Sel Abbott said that no matter if the admendment is in writing or not the Planning Board has the authority to ask for any information they want from sub dividors.

FINANCE COMMITTEE:

Millard Genther reported that they are all done with their work and have spent all the town's money. He said that they have spent approximately 680 thousand dollars.

BICENNTENIAL COMMITTEE:

Dianne Holden and Chrm Andrew C Woodsome, Jr reported that open ceremonies are scheduled for 3/6, also on that day the Post Office will be cancelling postage stamps. The dance will be held on 3/7 at the high school gym and tickets are on sale. The bill should be signed shortly by the Governor allowing the use of the Bicentennial License Plate. The logo drawn by a high school student, adpoted by the Bicenntennial Committee will be featured on the cover of the '87 Town report. Mention was made that people are stilled needed to join the various committees and people are also needed to act in the skit "Town Meeting 1787".

HAZARDOUS WASTE COMMISSION:
