Apparently the bids the Lions have received have been for quite a bit more. Sel woodsome, Jr told John that one day this week he will go with him and they can look for other companies to do the work for hopefully the ammount they have appropriated.

RUDY ROSS: Asked if he could use the Board outside to advertise about the Ossipee Lake Committee meeting Sat and if someone could call Don Trombly about taking pictures of the Softball teams. These things will be done for him.

DUMP ATTENDENT: Charlie Cressey was asked to meet with the Board to discuss a few things at the dump. Sel Abbott showed Charlie on the blackboard how the Selectmen would lke to see cars parked and how they would like for them to dump their stumps. Charlie said he will do his best to follow these instructions. The Board told him not to burn at the dump everyday, to do it when the dump was closed, and if a fire was still burning when he left to contact one ofthe selectmen and they would find someone to watch it. MUD STOMPERS: Dennis Edgerly, Lucien Owen, Virginia Owen and Bob Tardiff met with the Board about possibily holding a racing event at the N Waterboro Motor Cross track for the mud stompers. on Sunday August 23, 1987. The mud stompers said that they hire 3 or 4 retal cops and provide their own insurance. They would like to hold 2 events their this summer, apparently they have invested 20,000 in the track and are now broke, by having these two more races they feel they could raise a little money to invest in a track elsewhere. A public meeting will be held on Tueday July 21, 1987 at 7:30pm.

CLARKS BRIDGE ROAD: Judy Sterndale and Rocky Sterndale and Glen Graham met with the Board to discuss a piece of land they are interested in buying on a discontinued portion of the Clarks Bridge Road. Chrm Fay believes that even though there never was electricity on that road there still is an utility easement, Sel Woodsome, Jr was not sure. A call will be made to the Town Attorney for advice.
