SELECTMEN'S REPORT: Chairman Robert Fay reported. The Board signed the library agreement with the Lioness Club tonight. Will be signing the new snowplow contracts in May. Would like to set aside areas at the dump for a compost pile and separate white goods for people to buy.

TOWN CLERK/TAX COLLECTOR/TREASURER: Dianne Holden reported that monies received approximately \$50,000. for this year discounts. Expect that more will be in the last week. Dianne also explained the lien process.

ROAD COMMISSIONER: Fred Fay reported that he has been busy with his crew sweeping and patching.

SAD #57 DIRECTORS: Millard Genthner reported that the public hearings on the budget will be held April 30th at Shapleigh and May 3 at the Lyman school at 7:00 p.m. He hopes that there will be a large turnout. Willis Lord asked why so much was left out of the budget. Brenda Charland stated that it was the vote of the Board to drop allot out of the report. Sel. Monteith stated that he would like to see it back in so that people can see what they are voting on.

FIRE DEPARTMENT: Tom Jones reported for the Fire Dept. The Fire Dept. has gone in with Hollis, Bar Mills, Arundel, Limerick, Buxton, Goodwin Mills to purchase some equipment as a unit. The bids are due May 4 at which time they will go over the bids. Costs approximately \$600. to outfit a fireman. The equipment for the new truck is included in the bid. Also are looking into a piece of land in Lake Arrowhead with a joint effort with Limerick to house a fire truck.

PLANNING BOARD: Anna Jackson reported that a 36 lot mobile home park has been proposed. Only needs 12,000 sq. ft. per lot for a mobile home park. The new shoreland zoning laws went into effect this week. Roland Denby and Anna attended a meeting last night explaining the new laws.

TOWN PLANNER: Dwayne Morin reported. He has been busy last month. Have sent out the income surveys. CDBG grant has been finished. The wells at Waterboro Patent Leather should be in soon and test results available by June 1. April 25th at 7:00 p.m. will be a Comp. Plan workshop.

FINANCE COMMITTEE: Arthur Smith is the Chairman and the committee will be meeting with the Selectmen on May 1st at 7:30 p.m.

PARKS & RECREATION COMM: Bob Gobeil reported. Have been working on baseball and softball sign ups. Have signed up over 200 kids. The rule is every kid that signs up plays. There are five extra teams this year. The insurance was twice as high as they anticipated. Mike Vigue will be scheduling were the teams will schedule to play when and on what fields.

IDC COMM: No report.

ROAD REVIEW COMM: Doug Foglio reported that the committee met tonight to go over the study that has been done on Clark's Bridge Road. The committee discussed with the Town Planner about updating the snow plow routes on the maps. The bridge over Carll's Brook on the West Road is in need of repair. Sebago Technics looked at it and feels the bridge should be posted to weight limits. Willis Lord will check with the state to see if there are any fund available to have the bridge fixed. The committee also voted to recommend Sandy Drive be considered a Town Road.

ZONING BOARD OF APPEALS: Millard Genthner reported that th Board has had about seven cases so far this year. They will be having a workshop on May 7th with SMRP.

CONSTABLES: Chauncey Gerry reported that he has had several dog and cats complaints. Attended a class last Sat. in Biddeford on the new State Laws pertaining to animal control.

CONSERVATION COMM.: Stu Miller reported that they have not meet yet.

HAZARDOUS WASTE COMM: Kurt Clason reported that they have been working with the state on the underground tanks at the Milk Room. Also have been working on a regional hazardous waste pickup for the town.

REGIONAL WASTE: No report.

SOUTHERN MAINE REGIONAL PLANNING: Sel. Abbott is the representative for the Board of Selectmen and Dwayne Morin is the representative for the Planning Board.

CABLE TV COMM: Sel. Abbott explained the committee. There are six towns involved and they have a joint committee and will work out complaints, etc. Frank Allen will be representing the Town of Waterboro.

ASSESSING BOARD OF REVIEW: No report.

FAIR HEARING COMM: No report.

TAYLOR/FRYE/LEAVITT HOUSE BOARD OF TRUSTEES: The first meeting

will be April 30th. Jim Carll is the Chairman.

LIBRARY BUILDING REVIEW COMM: Anna Jackson reported that she is the Chairman of the committee. Have been getting volunteer work and supplies.

WATER TASK COMM: Dwayne Morin presented to the audience a map of the proposed water system route. Sel. Abbott reported that the contract has been signed. Hopefully the system will be in place before snow this year. There are 18 homes involved.
