SELECTMEN'S REPORT; Chm. Fay reported on the Special Town Meeting that will be held June 19th. Selectmen would also like the committee's to notify the office of when they meet, time and also copies of the minutes of their meetings. Board has been working on the snow plow contracts and hope to have them signed soon. The Board has been meeting with different committees. So far have met with the Finance Comm., Parks & Rec. Comm. and is scheduled to meet with the Conservation Comm. June 5th. Town will hold a clean up week May 26-June 1. At which time junk cars, tires, and white goods can be disposed of without fees paid. There will be a revote of the school budget May 22nd at 7:00 p.m. at the High School. The Selectmen's meeting has been cancelled that night. The summer hours at the dump will start June 17th thru Labor Day and will be Sundays 2-5 p.m. add to the current schedule. There will be a Public Hearing concerning Ossipee Lake Sunday June 3rd at 2:00 p.m. at the Town Hall.

TOWN CLERK/TAX COLLECTOR/TREASURER: Dianne Holden reported that about \$270,000. was recieved on 1990 taxes. Her office will be closing at 6:30 p.m. on May 22nd to attend the SAD vote. Have started lien proceedings on unpaid 1989 taxes approximately \$170,000. is outstanding.

ROAD COMMISSIONER: Fred Fay reported that he has been busy ditching and crushing material and putting signs up and has been sweeping the roads. Also has sent out the bids for seal coat and tar and the paving bids.

SAD #57 DIRECTORS: Millard Genthner reported that there has been \$50,000. taken out of the administration account for the new vote. There will not be a full time principal at Shapleigh School. The Administration account has a deficit of \$25,000. The Administration will be part-time until June 30 to make up for the \$25,000. Reminder of the budget meeting vote May 22nd at 7:00 p.m. at the High School.

FIRE DEPT: Tom Jones represented the Fire Dept. The bids has been received on purchasing gear. Cost about \$540. per man to outfit. With the bids a little-over \$400.00 per man.

PLANNING BOARD: Dwayne Morin reported for the Planning Board. Things are slowing down. Have received plans for a 36 lot mobile home park plus there are two subdivisions before the Board.

TOWN PLANNER: Dwayne reported that he has been working on the water system. Also has been working on the Community Development Block Grant, asking for \$950,000. including fire protection. Will be holding workshops on the Comphrehensive Plan for the next two Wednesdays.

FINANCE COMMITTEE: Chm. Arthur Smith reported that the Finance Committee met Monday night to go over the snow plow contracts.

PARKS & REC. COMM.: Bob Gobeil reported that 350 kids signed up for summer baseball and softball. At the Special Town Meeting in June, Parks & Rec. will be asking for an additional \$2,000. Will also have some kids from the state this year again to do some work. Also will be receiving 10% from the concession stand this year. Also are looking into a new ball field with help from the state.

ZONING BOARD OF APPEALS: Millard reported that they had a beneficial workshop last week. The Board has no appeals pending. Will be meeting with the Planning Board, Town Attorney and Board of Selectmen Thursday for a meeting on substandard lots.

CONSTABLES: Chauncey stated that there are alot of stray cats in bad shape. Willis Lord has received a petition with 650 signatures for a working light at the intersection of Rte. 202 and the West Road. Willis will be taking the petition to Augusta. Doug Foglio also has concerns with the parking along Rte. 202 from the corner you can's see to pull out onto 202.

CONSERVATION COMM: Stu Miller reported that they held an organizational meeting several weeks ago.

HAZARDOUS WASTE COMM.: Pam L'Heureux reported that they meet the second Tuesday at 7:00 p.m. Would like to set up a meeting with Parks & Rec., Conservation Comm., Hazardous Waste Comm., and Board of Selectmen. Dale Witman stated that he would like to see loads going to the dump covered.

FAIR HEARING COMM.: No report.

TAYLOR/FRYE/LEAVITT HOUSE BOARD OF TRUSTEES: Art reported that the Board did an inventory last week. The locks on the doors have been changed.

LIBRARY BUILDING REVIEW COMM.: John reported that the committee is doing well. Have been working on the ceilings, furnance room, and the handicap bathroom. Hope to be open in a couple of months.

WATER TASK COMM.: Chm. Fay stated that if people won't sell land to the Town, then the Town will take by eminent domain and let the courts decide on the amount. Sel Abbott reported that may be able to use CMP as an easement to run the water. There will be a meeting on May 31st. The survey that was done won't qualify for Farmers Home but showed that 52 additional homes showed interest into hooking into the water system. Also are looking at East Village. 1st funding \$105,000. from DEP, \$760,000. DEP to satisfy 18 homes and \$900,000 to expand to entire village and for fire protection.
