# SELECTMEN'S MEETING MINUTES JULY 5, 1994

Regular meeting of the Waterboro Board of Selectmen.

PRESENT: Dennis G. Abbott, John C. Monteith and Robert C. Fay. Also present: Selectmen's Assistant Dwayne G. Morin, Frank R. Allen, Jr., Millard Genthner and Glenn Bean, Sr.

## **REPORT OF STANDING COMMITTEES:**

MILLARD GENTHNER: Millard was in to discuss the tire disposal problem at the dump with Les Leighton. Policy is 4 per personal vehicle. Les told Millard that it was town meeting vote after he has disposed of 4 tires, he can come in with someone different each time and dispose of 4 more. Millard would like a letter sent to Les explaining the policy. Sel. Fay suggests having Les in to discuss it. The Board was in agreement, and will invite Les into a Selectmen's meeting to discuss it. Also discussed disposing of mounted tires. Millard suggests soliciting the area garages to see if they would participate in dismounting tires if they could dispose of two additional tires free of charge. Sel. Monteith suggests letting the area garages have the option of participating. Sel. Abbott agrees and do a rotation of garages that want to participate and to use the garages when there are five mounted tires to dismount. Board approved to allow Jims Getty to take the five tires that are there now and dismount them. Also discussed someone that keeps coming into the transfer station with a vehicle is registration in another town. He has been coming in for a year. Board agrees that he needs to purchase a \$10.00 laminated sticker. Reviewed plans drawn up by Sebago Technics on the transfer station. Dwayne will contact Clark Lumber to see if they are interested in selling a portion of their property to the Town that abuts the transfer station. D.E.P. has requested to install more monitoring wells around the old landfill. The Board agreed not to give them permission to install the wells, wasting taxpayers money. As of yet nothing has been found in any testing. D.E.P. is concerned over possibility of hazardous waste on site. The Board has concerns over if the cover is interrupted it could cause problems.

#### **NEW BUSINESS:**

The Fire Dept. still needs to submit an inventory list as per their contract with the town. The Board will invite the Fire Dept. in next week.
