## COUNCIL MEETING NOVEMBER 15, 1994

SELECTMEN: Sel. Monteith reported that Clayton Hurlburt has offered to sell to the Town 75 acres that he owns on Ossipee Mountain for \$40,000. Another 25 acre piece may be available in the future. The front foyer should be completed within a couple of days. The paving projects have been completed. The budget requests for June 1995 are out and are due Jan. 1, 1995.

TOWN CLERK/TAX COLLECTOR/TREASURER: Dianne Holden reported that last week 2,022 people voted in the election. Due date was today for the first half of the taxes and 74% have been collected. Has had the town reports and town records bound. Sel. Fay asked if there is a breakdown on party enrollment as to how many of each party voted. Dianne stated that those statistics are not kept. Now there is the Republican, Democratic, Independent and the Green Party.

ROAD REVIEW COMMITTEE: Fred Fay reported the committee will need to work on the budget for next year.

ROAD COMMISSIONER: Glenn Bean, Sr. reported the roads are paved. Haven't yet ordered the salt for the winter sand yet.

SAD 57 DIRECTORS: Millard Genthner reported all is quiet.

FIRE DEPT/RESCUE: Ginny Pare' introduced the new Asst. Rescue Chief Beverly Sinclair. Kevin Theriault is the new Fire Chief, Tom Jones the 1st Assistant, and Frank Birkemose 2nd Asst. All are planning to be at next month's Council Meeting.

PLANNING BOARD: Roland Denby reported that the Board needs to work on the zoning ordinance and shoreland zoning. No new subdivisions have come before the Board. Council mtg. 11/15/94 pg 2

TOWN PLANNER/SELECTMEN'S ASSISTANT: Dwayne Morin reported has been working with the Planning Board and also working on an economic grant for Horton's Foods. Frank Allen asked if this expansion would have an impact on the neighboring houses. Dwayne told him that all expansion will be within the building.

FINANCE COMMITTEE: Dale Witman reported is quiet now, should be going full tilt by the first of the year. Also requests that budget requests need further detail breakdown.

PARKS & RECREATION COMM: Bob Gobeil reported watering system is almost installed at the Lion's Field. Have been closing up for the winter and working on the skating rink.

ZONING BOARD OF APPEALS: Dale Witman reported that there are now three new members, John Murray, Barbara Krew and Fred Own.

HAZARDOUS WASTE COMM: Pam L'Heureux reported that all is quiet.

EMA DIRECTOR: Pam L'Heureux reported waiting to see who is going to take Pete Lamontagne place.

RWS: Frank Allen reported in the budget process. Still working on trash being hauled to PERC & MERC when it should go to RWS. Town gets charged \$55. a ton and commercial haulers \$68. a ton. Contract with CMP is for twenty some years. Looking at six associate towns becoming members to keep trash are RWS and tipping fees down. RWS is forbidden to solicit other towns to join RWS.

RECYCLING COMMITTEE: No one from the committee to report but Frank Allen stated that only 3 1/2% of the town is recycling.

OSSIPEE LAKE ASSOCIATION: Pam L'Heureux reported all quiet. Dianne Holden stated that Donald would like to apologize for not being able to attend the meetings due to working overtime.
