TOWN OF WATERBORO BOARD OF SELECTMEN MEETING MINUTES JULY 8, 1997

Attending: Dennis Abbott, Dale Witman, Brenda Charland, Pat Sicard. Also attending: Guest Sam

Evrard.

7:07 p.m. Chr. Abbott called the meeting to order.

7:10 p.m. Dave Dittmer, Parks and Recreation Director

Discussion: Parks and Recreation Summer Revenues, Checking Account, and Petty Cash amount.

Background information The Parks and Recreation budget was prepared for summer recreation based on expected appropriations plus revenue, and due to current information, may be in deficit spending. By Town Meeting vote on 3/8/97, the revenues were voted to become part of Miscellaneous funds, and any balance in the account would be zeroed at the end of the Fiscal Year.

Motion made by Dale Witman: To dissolve the checking account, return all revenues collected to the general fund under Miscellaneous Revenues, return any funds left on 6/30/97 to the General Fund, and that the Parks and Recreation Director be allowed \$500.00 for petty cash.

Brenda Charland requested that the motion be broken into sections for discussion and vote.

Chr. Abbott stated that the balance of funding for the department comes from Miscellaneous funds. Therefore, restating the Motion, the revenue collected prior to July 1, 1997 will go into Miscellaneous Funds. Brenda Charland second. All in favor. Motion carried.

Brenda Charland requested amending sections of the motion as follows: The Director would retain the checkbook with a balance of \$500.00. Second: Dennis Abbott Discussion: Dale Witman opposed. Vote called: 2 in favor, 1 opposed. Motion carried.

Chr. Abbott motion: Any fees collected after July 1, 1997 will be allocated to Miscellaneous Revenue. Brenda Charland second. Vote: All in favor. Motion carried.

7:45 p.m. Sam Evrard, Northern Data Services

Discussion: Upgrading Present Town Hall computer central processor

Sam Evrard presented three options for the Selectmen's consideration. The Treasurer, Town Clerk, Motor Vehicle Agent, and Tax Collector affirmed the need for upgrading, due to the present system's limited capacity and speed. Chr. Abbott requested a recommendation of options, and Sam Evrard recommended Option I, which will cost approximately \$23,000 and will put us up to date with the rest of the industry. A new system printer will be ordered to replace the malfunctioning 11 year old current printer, and the Motor Vehicle Agent will be given one of the unused PC's.

Chr. Abbott moved that the issue be discussed in the near future. All agreed. The computer upgrade will be placed on an August meeting agenda.

8:15 p.m. Elias Smith, Fire Chief

Discussion: Old Home Days Fire/Safety preparedness

Due to the recent fireworks accidents, Elias Smith was asked to attend, and stated that his whole "crew" would be available for the fireworks display. He requested that 2 policemen be stationed on Route 202, and that the Fire Marshall determined that 3 trucks must be present and determined the number of personnel. Bob Gobeil, Old Home Days Chair, does not have extra police coverage, but will contact the State and County departments. He also asked Elias Smith for a copy of the revised fire coverage rules.

8:35 p.m. Pam L'Heureux, E911 Chair, Fire Department Trustee

Discussion: Fire Tower Commemoration, 911 update, and Clerk/Paramedic Job Description

The job description for the Clerk/Paramedic, who is the only town employee for the Waterboro Fire Department, Inc. was presented in rough draft form, with a final draft for the Selectmen's review on 7/15/97 ready by 7/11/97. The job has been redefined to comply with labor laws. The Trustees are working on job descriptions for the Chief, Assistant Chief, Rescue and Fire volunteers, which will be presented in the future as "a package" for approval.

Pam discussed distribution of commemorative key chains at the Ossipee Tower Dedication in August. The Selectmen have not been informed that a large ceremony is planned, and Elias Smith will get the name of the organizer to Pat Sicard and Jason L'Heureux will get a copy of the information he has received to the Selectmen.

The E911 maps are completed, and when final review is completed in Augusta by mid-August, the Town will order and place new street signs. Pam explained the notification process will take place probably in October and is twofold: Residents are informed by both the Town and Post Office regarding new addresses. Pat Sicard has researched sign costs. Pam requested that the Town provide the new house numbers to residents.

9:00 p.m. NEW BUSINESS

- Assessor Resignation effective on August 3, 1997: Duly noted and received in accordance with current contract. Chr. Abbott stated that we have some time to take action to replace the Assessor.
- Olivolo consent decree on 3 foot setback violation and avoidance of tax title auction: Chr. Abbott motion: No approval or extension time. Dale Witman second. All in favor. Motion carried.
- Bagley consent decree on 3 foot setback violation: Chr. Abbott motion: Class D survey needed; no approval given. Dale Witman second. All in favor. Motion carried.
- Approval for employees to receive salary and COLA 4% voted at Town Meeting requested by Pat Sicard. Chr. Abbott made the motion to accept the request, with a request to have the system for giving increases defined in the Personnel Policy. Brenda Charland seconded, adding that this needs to be reflected in motions at Town Meeting. All in favor. Motion carries.
- Selectmen's Pay Schedule: Request from Treasurer for directions. Chr. Abbott motion: Each selectman will speak to the Treasurer if a change in the current 1/12 per month schedule is requested. Brenda Charland second. All in favor. Motion carries.
- Changing of locks following staffing changes: After discussion this received no support.
- Planning Board Clerical Support: Pat Sicard will contact the Planning Board Chair and request that
 the Board discuss needs at their next meeting on July 9, 1997, and request the Chair to meet with the
 Selectmen following the Town Council Meeting on July 15, 1997.
