# SELECTMEN MEETING OCTOBER 14, 1997

PUBLIC HEARING 7 P.M. To review the proposed Fire Department Ordinance.

Regular selectmen meeting begins at 8 p.m.

#### **OPEN DISCUSSION**

The sand bids that were submitted were opened. One bid was received from Northeastern Sand and Gravel at \$3.00 per cubic yard, and \$5.65 per cubic yard delivered and put up. A decision to award the bid is not made at this time. Information will be gathered for next week.

Judy Fay asks the Board how they go about appointing the Finance Committee. Dennis Abbott explains that the Selectmen discuss the applicants and then decide and the people who don't make the committee get notified. This year two people did not make the committee and the letters that should have gone out have not yet.

Ron Miller asks how does one go about complaining about a road Andrew's Lane. His neighbor stated that he has sent letters and received no responses. The Selectmen stated that they have not received any letters of complaint as well as Fred Fay states that he has not received any letters. Dennis States that normally one would call the road commissioner with a road complaint, or the selectmen's office to relay to the road commissioner. Ron said that he would forward a letter to both.

### **APPOINTMENTS**

8:10 Fred Fay regarding a letter received from the Poisant's who live on Ossipee Hill Road concerning a drainage problem. Fred Fay has been up there to look at the property and confirms that there is a problem. Dale Witman has also been up to look at it and says there is significant property damage. Fred will talk to the neighbors and see if the direction of the culvert can be changed and change the direction of the water. Fred will get back to the Board. Another issue Fred wanted to discuss is the Deering Ridge Road account. The road profile that the board had done by Sebago Technics was not budgeted for and therefore that account is overdrawn by that amount. Fred would like to get more money at town meeting to cover for that expense. Dennis states that annual town meeting we can go back and ask for the money to cover for the engineering. For now we will pay the bill. Fred states that they will be fine grading the road tomorrow and if it rains they'll pave this week. Fred gives the Board the information on the prices local people would charge to haul salt for the town. We will gather some more information and award the salt bids next week. Dennis requests of Fred information on the size of the loaders and excavators the town uses and the rates we are currently paying.
