7:05 p.m. – Guy Litalien representing the Ossipee Lake Association reported on his findings after researching the request to do water testing. Reported that the effects on fish and aquatic life have not been thoroughly studied but it does have an adverse effect. In 1998 did a study of 19 lakes for MTBE and it showed up in only 9 of the lakes. Little Ossipee was on of the 19 lakes studied and there was no cause for concern. Still waiting for a report done on Square Pond. Lake Association does not recommend spending the money to do this additional testing at this time. Roy Bouchard of the DEP reported that you can not do just one test, would need to do regular testing. Lake Association feels that educating the citizens would accomplish more. Brenda questioned if the DEP would do the testing at a lower cost. Guy listed the cost of all tests that they would recommend. Stated that it is very difficult to get definitive answers because conditions change all results. Brenda stated that since they did vote to do the testing a couple of weeks ago they should notify Mrs. Pellerin and allow her the opportunity to respond. Will place on next weeks agenda.
