#### SELECTMEN'S MEETING MINUTES October 19, 2004

**ATTENDING**: Douglas Foglio, Sr., Robert Fay, Nancy Brandt, Pam Witman, Pam & Ken Pierce, Darlene Montgomery, Dean & Denise Waterhouse, Cindy Moore and Beth Cyr.

Selectman Foglio called the meeting to order at 6:01 p.m.

## APPOINTMENTS

6:00 – Pam Pierce addressed the board requesting that the No Engine Brake signs be moved to cover a larger area of town. Selectman Foglio explained that this is an ordinance and would need to hold a public hearing to make a change. Also need specific locations designated within the ordinance for the sign location in order to make it enforceable. Selectman Foglio felt it should be a noise ordinance. Beth Cyr stated that she felt it should be on the town lines as in other towns. Darlene Montgomery stated that it is terrible on Route 5 and unnecessary. Selectman Fay requested that they bring in something the way they want it and will hold a hearing.

# **ADMINISTRATOR'S REPORT:**

- 1. Reported that final measurements will be done for the vault door on Friday and will be installing on Monday at 5 pm.
- 2. Intersection has gone out to bid. There have been 37 different plans.
- 3. Currently have had 340 absentee ballots cast and 75 new registrations.
- 4. Has gotten the rabies law clarified and the shot only has to be effective on the day they register the dog.
- 5. Been working on a contingency plan for election day in case something happens. Still needs to work out how to secure 10,000 ballots.
- 6. Reported that they need to change the charter for budget items to go to referendum vote.

### **NEW BUSINESS:**

- 1. Motion by Selectman Fay to sign the Consent Decree with a fine of \$10,000. Selectman Foglio agreed to second if they reduce the fine to \$7,500 and require that they replace the two boundary markers and cut the drainage pipe that is currently draining onto the neighbors property so that it drains onto their own lot. Selectman Fay agreed to the reduction in the fine amount. Seconded by Selectman Foglio. Voted. Passed.
- 2. Motion by Selectman Foglio and seconded by Selectman Fay to waive the taxes and interest due on the mobile home before being moved per Executive Session held October 12, 2004. Voted. Passed.

### **OLD BUSINESS**

1. Regarding Berube Builders: Have had the towns attorney draft a letter as the town requires and Selectman Foglio made the motion that they need to accept that within two weeks or will have the attorney draw up a cease and desist order. Seconded by Selectman Fay. Voted. Passed.
