

SELECTMEN'S MEETING
APRIL 19, 2007

PRESENT: Robert Fay, Dwayne Woodsome, Evan Grover, Cindy Moore, Pam Witman, Bob Gobeil, Dave Woodsome, Clint Andrews, Dean Waterhouse, Dep. Conger, Teresa Lowell, Kirsten Pacyna, Jane Harriman and TammyJo Girard

Selectmen Grover opened up the meeting at 7:03 p.m. with the pledge.

APPOINTMENTS

Dep. Conger reported that Townhouse road should be back open tomorrow. Also stated that the Fire Dept. did an awesome job during the storm. Reported that in March responded to 360 calls. Highlights for the month were the shooting call at the school which turned out to be a hoax, met with Goodall and not certain if they will have security, worked with three different businesses on checks written on a closed account and worked on theft of services and bad checks at one business and recovered quite a bit of the money. Discussed phone scams and reviewed calls for service in March. Jane Harriman questioned if the Sheriff's Dept. had anything connecting Sullies or their patrons to destruction of property both towards Sel. Grover as well as some of her neighbors. Dep. Conger stated that he would have interviewed her if there was anything and he has not heard any complaints. Jane stated that there are articles in the paper indicating she or her patrons were committing these crimes. Dep. Conger said that if there were any truth to that he could assure her that she would have been interviewed. Selectman Grover stated that he has no knowledge of any of this and certainly never thought she was involved. Selectman Fay stated that he did vote against her liquor license so that the state would handle it but does not like to see what's happening now with all the allegations being made from both sides. Dep. Conger stated that he has no information with regard to Jane or Sullies and there is not even a case open.

Selectman Grover stated that Chief Bors was not able to attend regarding the agreement with EMA to take over the airboat but they do have all the information to vote on the agreement.

Selectman Grover reported that the Town Administrator is not present as she is working on the election due to the Town Clerk being ill.

Selectman Grover announced that anyone with damage from the storm should call the Selectmen's Office. Selectman Woodsome stated that we were hit hard but it is minimal compared to some towns around and warned everyone to be careful when driving around southern Maine.

Selectman Fay stated that Tuesday we had no power and therefore had to close townhall

NEW BUSINESS:

1. Motion by Selectman Woodsome and seconded by Selectman Fay that the Town of Waterboro and York County EMA on the continuance of the operation of the Yankee Air Boat and that the Town of Waterboro will allow York County EMA to operate the airboat and to allow them to store it in the old Center Station. Vote 4-0-0.

2. Clint reviewed the options for the Transfer Station hours. Selectman Fay was fine with the hours recommended but would prefer that the hours be 1 to 5 on Sunday instead of Noon to 5. Selectman Woodsome felt that Noon on Sunday would be difficult with the church at the end of the road. Motion by Selectman Fay and seconded by Selectman Woodsome to go with recommendation of Wednesday 12-7, Friday and Saturday 9-5 and Sunday 1-5 for the summer and Wednesday 12-5, Friday and Saturday 9-5 and Sunday 1-4 for the winter. Selectman Woodsome stated that this makes it easier for D & E when they are closed on Monday giving him time to move containers around. Vote 4-0-0.
3. Motion by Selectman Fay and seconded by Selectman Woodsome to extend the contract with D & E for two years. Vote 4-0-0.
4. Dave Woodsome explained that in revising the Solid Waste Ordinance they removed things that no longer applied and added other things. Discussed commercial composting. Discussed fees and TammyJo questioned why this isn't handled under the state statute and then it could be handled by any law enforcement officer not just our contract deputy. Will bring back next week with changes. Section 7, Section B & Section 4 will be reviewed. Tomorrow the recycling committee will have a table at the election and will ask the voters to answer a quick questionnaire. Stated that they still need volunteers to man the booth. Motion by Selectman Moore and seconded by Selectman Fay that a public hearing be scheduled for May 8th at 7 pm. Vote 4-0-0. Selectman Fay stated that they need to add to next week's agenda to appoint another Selectman to the Transfer Station/Recycling Committee.
5. TammyJo reported that under Section 4 part D they removed the wording "any stop sign". Discussed fines and tickets. TammyJo suggested printing the fine amount on the ticket. Felt the fines should be \$10 for first offense and \$25.00 for the second offense except handicapped which would be \$100 and double if not paid in 30 days. Motion by Selectman Woodsome and seconded by Selectman Moore that the fines be \$10, \$25 and \$100 and that the Public Hearing be on May 8th at 7 pm. Discussed towing zones. Vote 4-0-0.
6. Motion by Selectman Woodsome and seconded by Selectman Moore to put aside the funds as requested for Waterboro's share of the franchise renewal legal costs. Vote 4-0-0.

OTHER

1. Motion by Selectman Woodsome and seconded by Selectman Moore to sign the warrants for bills & payroll. Vote 4-0-0.
2. Selectman Woodsome read reminders. Also asked that people have a little patience with the state and town to repair roads.
3. Selectman Grover asked that you check on elderly if they are still without power.
4. Selectman Woodsome reported that Scooter Way and a section of Bennett Hill Road will be closed for a length of time.
5. TammyJo thanked Bob for all his years of service.
6. Selectman Woodsome stated that if you need a ride to vote call the town hall and it will be arranged.

HEARING OF DELEGATION

1. Selectman Woodsome reported on the request from the Transfer Station/Recycling committee that Earth Day be advertised on the outside sign.
