TOWN ADMINISTRATOR'S REPORT

1. Reported that she is still working on the budget. Will be meeting on Thursday with three Dept. Heads to get more information on their revenue.

SELECTMEN'S REPORT

1. Selectman Grover reported on the Transfer Station/Recycling Committee meeting. Stated that they are now charging for CFL bulbs and more are showing up in the household trash. The committee would like to change the policy so they are free to residents as well as anti-freeze. Will discuss and vote on next week. Also discussed the permitting and discussed getting the contract deputy involved in illegal dumping. Suggested having Deputy Sanborn attend the next Transfer Station meeting. Fred reported that he picked up a lot of trash on the New Dam Road today. Discussed holding a clean up day.

COMMITTEE REPORTS

1. Dustin reported that he had dropped off a previous letter to MDOT regarding Central York County Transportation Study. He and Tom Ursia talked with one of their engineers two months ago and noticed that they had left Waterboro out of this study. Told the engineer we were very interested and followed it up with a letter signed by all the road review members and Selectman Girard. Since then have gotten a draft letter back which we made some corrections to and it has been sent back. Just goes to show that our hard work is paying off and they are definitely paying attention to Waterboro now. Have a new letter which the committee would like the entire board to sign to show their support. Agreed to put on next weeks agenda. The committee had put in for a radar speed trail from the state and did get it. Will pick it up August 3rd and have for two weeks will then take to another town. Can also use the one from York County Sheriff. Reported that Tom is also working on getting a traffic counter. Has been working on the Old Alfred Road problems, checking every other day and another member is taking pictures.
