Town Administrator Gary Lamb's report was delivered as follows:

- Absentee ballots...available now from Town Hall...and early voting has also begun in Town Hall front lobby. Four questions on the ballot...casino in York County citizens initiative, Medicaid expansion citizens' initiative, roads and bridges, ports and trails bond question...and constitutional amendment to amortize state retirement plan investment losses over 20 years instead of the present 10 years.
- Marijuana update...last week the legislature substantially changed their draft bill that rewrites what was passed last November. The change, if passed by legislature and signed by the Governor, is that all Maine Towns are automatically prohibited from selling any form of retail marijuana....unless and until they pass their own ordinances allowing it. Up until last week, the Nov 2016 citizens' initiative forced towns to opt out if they wanted to prohibit sales (like Waterboro did)....now it is just the opposite. This does not affect towns like Waterboro that have prohibited all five new retail sales categories. These changes do NOT affect presently legal medical marijuana and personal uses and growing activity.
- Property taxes.....payments are due by 5pm Friday Oct 20 in town hall or mailed. Payments must be postmarked Oct 20th. Interest accrues starting Oct 21st.
- West Road snow removal contract... a RFP ad will be in Oct 13 Smart Shopper and Oct 17 Reporter to bid on snow clearing for the 0.4 mile of West Road sidewalk. Bids will be opened Friday Nov 3rd at noon.

The Board of Selectmen discussed the recent incident at the Transfer Station. They requested Dave Benton establish an action plan to ensure this would not happen again.

Public Safety Committee member Joshua Godard attended the meeting to share his thoughts and concerns with the Board of Selectmen. He commented on the lack of meetings, his attempt to correspond with other members, and lack of Board of Selectmen guidance. He commented that the committee could do very well, but is quite frustrated with little direction.

It was decided to have a meeting with the Board of Selectmen and bring in Fire Chief Matt Bors, the Fire Department Captains, the Contract Deputies, and the Public Works Director.
