He reported that as of June 30, 2018 there was \$5.2 million in assets with \$1 million in liabilities and obligations, leaving \$4.1million in fund balance. \$1.8 million of this amount is undesignated. The Town is fiscally sound and he suggested establishing a calculated capital reserve plan and show the crisis fund separate from the general fund.

- Gary Lamb showed a photo of a mountain of trash piled up next to our compactor only because our contractor refuses to supply truck service on Sunday to change our full containers. During the FY19/20 budget discussions, we will consider buying our own container truck so we can swap out compactor containers when needed.
