WARRANT

York, ss.

State of Maine

TO ARTHUR W. BRACKETT, a Constable of the Town of Waterboro, in the County of York and State of Maine, GREETING:

IN THE NAME OF THE STATE OF MAINE, you are hereby commanded to notify and warn the Inhabitants of said town qualified to vote in town affairs, to meet at the TOWN HOUSE, in said town, on Monday, the eighth day of March, A. D., 1937, then and there to act upon the following articles, to wit:

First: To choose a Moderator to preside at said meeting.

Second: To choose all necessary officers for the year ensuing

Third: To see what sum of money the town will grant and raise for the repair of roads and bridges for the ensuing year.

Fourth: To see if the town will vote Yes or No on the question of appropriating and raising money necessary to entitle the town to state aid as provided in Section 20 of Chapter 25 of the Revised Statutes of 1916.

Fifth: To see what sum of money the town will grant and raise in accordance with the provisions of Chapter 154 Public Laws of 1917, as amended, for the construction of state highways designated as "State Aid Road, No. 3".

Sixth: To see what sum of money the town will grant and raise for winter roads.

Seventh: To see what sum of money the town will grant and raise for State Road Patrol.

Eighth: To see what sum of money the town will grant and raise for the support of a Free High School for the ensuing year.

Ninth: To see what sum of money the town will grant and raise for the support of the Common Schools for the ensuing year.

Tenth: To see what sum of money the town will grant and raise for the repair of school buildings for the ensuing year.

Eleventh: To see what sum of money the town will grant and raise for text books and supplies for the ensuing year.

Twelfth: To see what sum of money the town will grant and raise for salary for the District Superintendent of Schools.

Thirteenth: To see what sum of money the town will grant and raise for Public Health Nurse, for the ensuing year.

Fourteenth: To see what sum of money the town will grant and raise for the Support of Poor for the ensuing year.

Fifteenth: To see what sum of money the town will grant and raise for Incidentals for the ensuing year.

Sixteenth: To see what sum of money the town will grant and raise for State Tax for the ensuing year.

Seventeenth: To see what sum of money the town will grant and raise for County Tax for the ensuing year.

Eighteenth: To see what sum the town will grant and raise for Road Machine Work , 50-50, for the year ensuing.

Nineteenth: To see what sum of money the town will grant and raise for the Principle and Interest on Town Bonds for the year ensuing.

Twentieth: To see what sum of money the town will grant and raise for the Observance of Memorial Day.

Twenty first: To see what action the town will take with reference to the Town Farm for the ensuing year.

Twenty-second: To see what sum the town will grant and raise for the payment of Interest on tax anticipation notes for the ensuing year.

Twenty-third: To see if the town will vote, that for the purpose of procuring a temporary loan, or loans for the use of the town of Waterboro to pay indebtedness of said town due and to become due, during the municipal year 1937, such loans to be paid out of money raised by taxation during the municipal year beginning March 15, 1937 and ending March 15, 1938, the Town Treasurer be, and hereby is authorized and directed to borrow from time to time, a sum or sums, not exceeding in the aggregate Fourteen thousand dollars, said sum being less than the tax levy of the preceeding municipal year and to execute and deliver a note, or notes, of the town therefor, signed in his official capacity as Treasurer, countersigned by the Selectmen, all of said notes, or any renewal or replacement thereof shall be payable on, or before, Dec. 31, 1937.

Twenty-fourth: To see if the town will authorize the Collector to charge interest on all unpaid taxes at the rate of one half per cent per month upon all taxes unpaid October 1, 1937, interest to begin on September 1, 1937.

Twenty-fifth: To see what sum of money the town will grant and raise for the cutting of bushes on improved roads during the ensuing year and to see what method the town will adopt in the cutting of the same.

Twenty-sixth: To see what sum of money the town will grant and raise for the extermination of brown-tail moths during the ensuing year.

Twenty seventh: To see what sum the town will grant and raise for the Maintenance of Third-Class Roads in accordance with the requirements of the Public Laws of Maine for 1929

Twenty eighth: To see if the town will vote to raise and ex-

pend the sum of one hundred and fifty dollars for Repairs on the Roberts Ridge Road, so called, on the petition of Walter Durgin and seven others.

Twenty-ninth: To see if the town will vote to grant and raise the sum of two hundred dollars for the repair of Pearl Street, in South Waterboro Village, on petition of Amy G. Brackett and fourteen others.

Thirtieth: To see if the town will vote to authorize this town's Committee representing the York County Tercentenary Commission, with the approval of the Board of Selectmen as to location, to erect Historical Markers which the Commission will furnish, or authorize, without cost to the town, on town property and alongside the traveled portions of its highways.

Thirty-first: To see if the town will vote to instruct its Selectmen to contract with the lowest responsible bidder, or bidders, to rebuild the large chimney in the town farm buildings and to paint the walls and roofs of the same buildings and, if so, to see what sum the town will grant and raise for this purpose.

Thirty-second: To see what action the town will take regarding the recommendations contained in the Report of the Finance Committee relating to Delinquent taxes due the town of Waterboro.

Thirty-third: To see if the town will grant and raise the sum of one hundred dollars for the repair of the road leading by the residence of A. I. Davis.

Thirty-fourth: To see if the town will grant and raise the sum of three thousand dollars to be used as an inducement to secure the location of a manufacturing company in the building known as the Goodall Mill, at South Waterboro, said sum to be paid to the concern so interested in locating at this point and used in the discretion of the Waterboro Board of Trade.

Thirty-fifth: To see if the town will vote to adopt the Australian ballot for use in town election. Petition of R. H. Bradeen and 12 others.

Thirty-sixth: To transact any other business that may lawfully come before said meeting.

The Selectmen hereby give notice that they will be in session at the town house at 9 o'clock of the morning of the annual town meeting for the purpose of correcting the list of polls of those entitled to vote in municipal affairs.

REPORT OF THE FINANCE COMMITTEE

DELINQUENT TAXES.

This Committee has carefully considered the matter of delinquent taxes due the town of Waterboro, and this is their conclusion: They recommend an article in the warrant be inserted and the voters be allowed to express their opinion on this matter, which we divide into two parts. First: There are certain of these taxes that we recommend be abated for the reasons set forth in each instance. In the case of others, we recommend that the Finance Committee for 1937 be given authority, as heretofore, to compromise any of these outstanding obligations and, if they decide it to be wise, an Attorney be employed to bring suit on every unpaid tax balance.

WOOD-CUTTING PROJECT.

Had Dr. Abbott not been incapacitated, he would have made a report on this matter at this time. As he and I are the only persons at all familiar with the proposition, I am making this report in his stead.

Last year, (1935) the poor problem was acute and we co-operated on this project, namely: To allow any of those receiving aid to cut wood on the Hamilton lot, so called, but owned by Agnes L. Nash of Somersworth, N. H., and giving them a credit for groceries for the amount of wood cut at a certain price per cord. This lot I was caring for, for the owner and it is not a "town wood lot" as some have described it. The wood so cut was sold by the town the receipts therefor was shown in last year's report. During the present year,

more wood has been cut in the same way, but this is on the lot and unsold. There have been no receipts for wood sold and no payments made to me for Mrs. Nash for the stumpage, which is \$1.00 per cord. I therefore, the statement in the "Delinquent" column that Mrs. Nash is delinquent \$18.00, while true so far as the collector is concerned, will present a different phase when payment is made to her for the wood already cut.

TOWN DEBT - RE-FINANCE

With the sale of the town farm timber and the collection of a considerable amount of delinquent taxes, as also the great benefit to the town through the W. P. A. fund that completely removed several people from the poor department list for a considerable period, an opportunity presented itself to re-finance our many outstanding obligations at a rate of 3 3/4 per cent, and practically all of which were drawing six per cent interest. To do this, it was necessary to borrow \$3,000.00 on a tax anticipation note at 3 per cent in order to bring the funded indebtedness of the town below the debt limit required by the Constitution of Maine. We are hopeful of soon receiving a considerable sum to reimburse the

town partially for the expense of support of Mary Thompson and this should be applied toward the payment of this note, which is still outstanding. We are hopeful to realize a considerable sum from delinquent taxes and the future prudent conduct of our town government will make the extinguishment of this debt a small matter.

We have now outstanding, beside the note mentioned, 29 bonds of the value of \$1,000 00 each, \$2,000 00 of which are to be retired annually. This is a fixed charge for which we must provide annually. In addition, we must provide for the interest on all bonds at each annual meeting and which, according to the terms thereof, must be paid semi-annually.
